PROJECT DESCRIPTION	Pre-design scoping study to determine approach for reconstructing I-264/US 42 interchange and to evaluate potential corridor and interchange improvements at this interchange.

PURPOSE AND NEED	Examine capacity and safety issues on I-264 and US 42 at interchange, and determine the future adequacy of the roads within the study area.
PROJECT LENGTH	Approximately 0.6 mile
METHOD OF DESIGN	The selected consultant shall utilize the CADD Standards for Highway Plans (version 2.08) policy in the development of the Highway Plans.
DBE REQUIREMENT	The consultant team shall include a DBE Participation Plan with their response to announcement. An additional page will be allowed with the project approach in the Response to Announcement to convey this plan. A maximum of 4 points will be considered in the evaluation factors for the DBE Participation Plan.

SCOPE	Conduct preliminary engineering studies to determine the future adequacy of the I-264/US 42 interchange, and examine capacity and safety issues on I-264 between the I-71 interchange and the proposed KY 1447 interchange. In addition perform capacity and safety studies on US 42 in the vicinity of the I-264 interchange. This will include traffic flow analysis, typical section, line and grade, dependable cost estimates, identifying Right-of-Way and utility conflicts with possible mitigation, identifying drainage issues, traffic control considerations, necessary structure modifications and possible enhancements to overhead signing and pavement markings. Ultimate-build and interim-build options need to be considered for funding flexibility. The Consultant will be responsible for the preparation of an environmental overview.
SPECIAL INSTRUCTIONS	The contract will be for Scoping Study only. If the Department decides to proceed with preliminary and final design, the scope of work will be advertised for consultant.

TRAFFIC	<p>The selected consultant shall utilize historical traffic information as available from the Traffic Counts System (CTS), which is accessible through the KYTC Division of Planning website: http://www.planning.kytc.ky.gov/data_reports.asp</p> <p>For KYTC review and approval, the consultant shall provide a growth factor. Mainline and ramp traffic volume and class projections within the project limits shall be included by the consultant. The consultant shall conduct traffic volume counts including vehicle classification counts as required during phase II design. Data collected shall be provided in Department standard format.</p> <p>The selected Consultant shall develop VISSIM or similar model to analyze existing conditions and alternates of the I-264/US 42 interchange and the respective interactions with the interchanges at I-264/I-71 and the proposed interchange at I-264/KY 1447. In accordance with FHWA practice, the Highway Capacity Manual (HCM) and/or Highway Capacity Software (HCS) shall be used to verify the results of the traffic model developed.</p>
RIGHT-OF-WAY	The selected consultant shall identify property owners within the project limits. Property owner information shall be shown on the plans along with existing right-of-way and property lines.


