An additional page will be allowed with the project approach in the Response to Announcement to convey this plan. A maximum of 4 points will be considered in the evaluation factors for the DBE Participation Plan.

SCOPE	The selected consultant will be required to provide Phase II (final roadway) design engineering services for the project. This includes the preparation of design studies, drainage design, right of way plans, construction plans, traffic control plans and cost estimates
