PURPOSE AND NEED	<p>Purpose and Need: To ensure the continued structural safety of these nineteen (19) Ohio River Bridge structures for use by the motoring public by providing fracture critical inspections mandated by the FHWA and performed in accordance with the National Bridge Inspection Standards.</p> <p>Reports are filed with Division of Maintenance records as well as recorded electronically. Copies of reports are also shared with District personnel and adjoining state DOTs. Inspection reports are used to determine needed repairs, allow for KYTC to prepare a budget for future years and share information and trends with other states.</p> <p>With the increasing traffic volumes and truck weights these inspections are needed on a timely basis.</p>

## SCOPE OF WORK

Four (4) Consultants will be selected (1,2,3,4). The Consultant ranked first will be awarded first choice of the four (4) packages. The Consultant ranked second will be awarded choice of the remaining three (3) packages. The Consultant ranked third will be awarded choice of the remaining two (2) packages, and the Consultant ranked fourth will be awarded the remaining package. Consultants must be prepared to make selection at the time of notification of ranking by the Selection Committee. Inspection packages are randomly listed and do not necessarily reflect the order of importance or anticipated contract size.

## SPECIAL INSTRUCTIONS

The Department may modify the Selected Consultants Agreement to include bridge inspections and/or necessary engineering services associated for this project. The additional related engineering services may be requested up to a contract upset limit of \$150,000 above the initial contract upset limit of \$150,000, above the initial contract amount for each contract package.
