**ACTION:**

The Radcliff/Elizabethtown Metropolitan Planning Organization (MPO) hereby modifies the FY 2018-2022 Transportation Improvement Program (TIP). This modification reflects the addition of the following Transportation Alternatives Program (TAP) project:

**DESCRIPTION/JUSTIFICATION:**

**18-027** – Installation of Pavement Markers on Various Routes in District 4 (Hardin County Routes - US 31WB, KY 61, and KY 251) – Funding Type – SAF – \$165,000

**18-028** – Intersection and Corridor Improvements to Reduce Conflict Points and Enhance Safety and Capacity along US 31W from Diecks Drive to Pine Valley Drive – Funding Type – SAF – \$2,375,000

**4-154.20** – Improve Safety and Mobility and Reduce Congestion on US 31E from US 31WB to KY 447 – Funding Type – SPP - \$2,750,000 – This project is a State Funded project and has been added as a regionally significant project for illustrative purposes.

*High-Cost and Low-Cost Safety Improvement project types are classified as Grouped Projects in the TIP; therefore, a formal amendment is not required.*

**FISCAL CONSTRAINT:** Funding for these improvements has been committed by the Kentucky Transportation Cabinet (KYTC); therefore, financial constraint of the TIP is maintained, as demonstrated in Table 11.
