On August 24, 2020, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #33 to the FY 2017 – 2020 TIP and Modification #16 to the 2045 MTP. This modification is considered a Grouped Project\* (Pavement Resurfacing, Restoration, and Rehabilitation) which does not impact the financial constraint of the TIP.
