

TIP Administrative Modifications

The Kentucky Transportation Cabinet (KYTC) requested the following modification:

ID# 02-20058 US 41 from MP 15.983 to MP 19.581: Address pavement condition (Grouped Project: Pavement resurfacing, restoration, and rehabilitation projects) Add Preliminary Engineering (PE) in FY 2021 at a total cost of \$375,000 and CN in outer year for a total of \$3,750,000. The contract will be funded with 80% Federal NHPP Funds and 20% State Match.
