SUBJECT: Notification of **Administrative Modification #20** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #39 to the 2045 Metropolitan Transportation Plan (MTP)

On August 4, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #20 to the FY 2021 – 2024 TIP and Modification #39 to the 2045 MTP.

Administrative Modification #20:

This action updates the previously published documents and tables:

- **Armstrong Mill Bike/Ped Improvements:**
 - Add 0.2 miles to the project length by extending the eastern terminus of the project from Kenesaw Drive to Squires Hill Lane, bringing the total project length to 2.2 miles.

This project is considered a Grouped Projects* (Bike/Ped Facilities) which does not impact the financial constraint of the TIP. This extension can also be made within the existing project budget.
