HB241 Report (FY2022-2024) Utilization of \$200,000 airport Improvement Grant Funding

SUMMARY: HB241 which distributed \$200,000 to all eligible airports in Kentucky, allowed airports across the state to address critical safety issues, maintenance and repairs, and airport projects which had been postponed due to lack of funding.

- Over 33 Airports utilized funds as local match on current or future projects with the state and in some cases leveraging federal funds.
- 15 Airports utilized the funding to purchase equipment that the state's transportation funds do not typically cover.
- Many airports invested their funding in hangar repairs or vertical development and fuel system repairs, or equipment, which has a direct return on investment.
