**VI. FINES: D Crane – July 7, 2025.**

On July 7, 2025 D Crane erected a crane near Louisville Muhammad Ali Intl Airport, SDF, without obtaining a KAZC Permit prior to commencing operations.

At 8:00 am on July 7, 2025, a 164 ft crane located 0.51 nm/3,072 ft from SDF 17L/35R was visible from SDF.

When the D Crane scheduler was made aware of the crane being in the air without a KAZC Permit the crane was lowered.

At 8:06 am on July 7, 2025, the D Crane scheduler sent an email request for a KAZC Permit to the KAZC email mailbox.

The location and height requested by D Crane required the Runway Closure of SDF 17L/35R as it penetrated the Approach Surface of SDF 17L/35R by 107+ ft.

A KAZC Permit was issued for this location and height at 10:51 am on July 7, 2025.
