The crane company was notified that a permit was required. American Roofing submitted a Temp Permit application, and a Permit was issued for Oct 31 – Nov 5, 2023.

DISCUSSION: The Permit expired in 2022. The crane was lowered when asked. A new application was submitted and an updated permit was issued.
