Discussion Items:

Treasurers Report

Ian provided a treasurer's report. He discussed the balances for the KBBC accounts. Ian also mentioned a meeting with the new person who works in the Licensing department (who works with the Paula Nye account). Ian also mentioned the audit is still ongoing but should wrap up soon.

2023 Lake Cumberland Project

Keith provided an update that KYTC HSIP (Highway Safety Improvement Program) may be providing funds for this project. Keith mentioned that this project should be pulled, and they could reapply again if it is still needed. Commissioners discussed calling the project sponsor and discussing.

Paula Nye Grant Application Review

Bike Walk BG

This request is for Bike Education and a Bike Garden. The commission decided to partially fund this request to focus more on the Education component. The request was for \$16,152. The application was funded at \$10,000.

Central KY Wheelmen

This request is to support bike education programming and to purchase a trailer for transporting bicycles for education purposes. The commission decided to partially fund this application based on removing trailer graphic art from the funds. The request was for \$15,500. The application was funded at \$13,110.13.

Norton Children's Hospital Foundation

This request is for prevention and wellness bicycle safety rodeos and education programming. The commission supports this entity and their work and decided to fully fund the application. The request was for \$5,204.12. The application was funded at \$5,204.12.

All Kids Bike (Sandersville Elementary School Lexington KY)

This request is to purchase an all-in-one bike education program from a national nonprofit group. The commission decided to fully fund this program to create a bike education program at this school. The request was for \$9,000. The application was funded at \$9,000.

This request is for a bicycle safety campaign in Northern KY. This would include pop-up bike shops, low-stress bicycle maps, reflective gear. The commission supported this application and decided to fully fund this. The request was for \$7,350. The application was funded at \$7,350.

YMCA Camp Ernst MTB Program

This request is to fund Mountain Bike Education and training programs. The commission decided to partially fund this and encourage the applicant to look at lower cost ways to run the program. The request was for \$11,500. The application was funded at \$6,500.

YMCA Camp Piomingo MTB Program

This request is to fund Mountain Bike Education and training programs. The commission decided to fully fund this request. The request was for \$4,200. The application was funded at \$4,200.

Heartland Chapter of National AMBUCS Inc.

This request is to fund the purchase of tricycles designed for children and adults with disabilities. The commission supports this mission and decided to fully fund the application. The request was for \$5,159.75. The application was funded at \$5,159.75.
