SUBJECT: Federal-aid Highway Construction Contractors Annual EEO Report

Form FHWA-1391

The FHWA-1391 form must be submitted by all contractors, including subcontractors, on <u>all</u> Kentucky Transportation Cabinet **Federal-aid** Highway projects with a contract or subcontract value totaling \$10,000 or more. Prime contractors are not responsible for submitting subcontractor reports on their projects but are responsible for ensuring all subcontractors are aware of the requirement. Contractors should use the FHWA-1391 form found at https://transportation.ky.gov/Construction-Procurement/Pages/default.aspx under Bulletins.

Employment data on the form should represent the project work force during all or any part of the of the last payroll period preceding the end of July 2021. Any contractor that was inactive during this reporting week is required to submit the FHWA-1391 form indicating they were "Inactive."

All FHWA-1391 reports must be received in the Division of Construction Procurement by the close of business on August 20, 2021. The reports are to be emailed to kytc.fhwa1391form@ky.gov. Failure to submit the FHWA-1391 by the established deadline may result in the withholding of pay estimates.

- Provide a 1391 <u>only</u> for Kentucky Transportation Cabinet Projects. Each project should include the Contract Id Number (ex. 19-1234) and a Federal Project Number (ex. STPM 1234 (567).
- 2. A 1391 is required <u>only</u> on Federally Funded Projects. State Funded Projects are not applicable.
 - Federal Funded Projects Applicable: (IM, NH, STP, BRO, BRZ, CM, FH, HSIP, APD, AID, HPP, KYD, SAF, TE)
 - State Funded Projects Not Applicable: (FD04, FD05, CB06, FE)
- 3. Where applicable complete <u>only</u> the blue, purple and yellow areas of the form. Other areas of the 1391 form will calculate the appropriate totals. Fix any errors highlighted in red.
- Forms should be completed by August 20 and emailed to kytc.fhwa1391form@ky.gov
- 5. Do not send form by US Mail, this will cause duplicate entry.
