3. John Mussman:
 - a. Question: What payment item will removing the debris net fall under?
 - b. Answer: Payment for the removal of the debris collection system shall be incidental to “Removal of Deteriorated Masonry” and payment for masonry repairs to the collection system anchor locations shall be incidental to the bid item “Masonry Patching Repair”.








