- Q. Will existing structure plans be made available to the contractor?
- A. Yes, the existing structure plans will be posted under the "project related information" link on the Cabinet's Construction Procurement web site. No existing plans are available for the FE02 024 0508 B00080N Structure
- Q. Does joint material in the curb and plinth on the FE02 024 0117 B00034N and the FE02 024 0117 B00035N structures get resealed as in the bridge deck?
- A. Yes, the joint material in the curb and plinth shall be resealed as in the bridge deck. All cost associated with this will be incidental to joint sealing.
- Q. Will any guardrail be clean and painted on any of the structures having guardrail?
- A. The guardrail on the FE02 0189 B00064N structure shall be cleaned and painted. The guardrail posts <u>only</u> on the south side of the FE02 024 0508 B00080N structure shall be cleaned and painted.
- Q. Will there be any time of day restrictions for the lane closures?
- A. There will be no time restrictions for the lane closures.
- Q. Where will the waste storage area be permitted?
- A. The waste storage area will be located at the KYTC Christian County Maintenance Barn. Access will be coordinated by the Resident Engineer.
- Q. Will 24 hour monitoring be required for the EPA ambient air monitoring for toxic Metals (TSP-Lead)?
- A. Yes 24 monitoring will be required from the 3 day background throughout the entire cleaning and painting operations until all containment is remove and cleaned.
- Q. How many TSP air monitoring pumps will be required for each structure?
- A. Two pumps for the FE02 024 0107 B00117N Structure and one pump will be required at each of the other five structures. The location of the pumps will be determined by the engineer.
