The Federal Highway Administration (FHWA) provided the Kentucky Transportation Cabinet (KYTC) a list of highlighted projects from the May 22nd, 2025 letting advertisement in which the DBE Injunction plaintiff(s) were interested. FHWA requests KYTC to issue an addendum on the highlighted projects to reduce the DBE contract goal to zero percent. Guidance concerning the injunction may be found in the document "Preliminary Injunction Affecting Disadvantaged Business Program," issued on November 18th, 2024. In addition, the selected projects from the May 1st advertisement are attached. An addendum will be processed to remove the DBE contract goals for these projects.
