SUBJECT: Revised Prequalification for Work Item
J-87 Video & Laser Pipeline Inspection

Effective April 1, 2015, the requirements for work item J-87 Video & Laser Pipeline Inspection will change.

Below are the additional necessary minimum requirements to be prequalified in this item.

Provide documentation that the company has access to a minimum of one (1) individual that is certified through the Kentucky Transportation Center's (KTC) Post Installation Pipe Inspection Certification Program. Documentation shall consist of a signed certification letter from Kentucky Transportation Center (KTC) which includes the following information: Name of individual successfully completing the program, Type of equipment used during the certification program, Date of certification testing and length of time the certification will remain in place. This certification is specific to the equipment used during the KTC inspection program.

A letter requesting this work item be updated, along with the proper documentation is to be submitted to the Division of Construction Procurement. Contractors who do not provide the necessary updates will have their Video & Laser Pipeline Inspection work item removed from their Certificate of Eligibility effective at the close of business on March 31, 2015. A Prime or a Subcontractor must be Pre-Qualified by the Kentucky Transportation Cabinet, Division of Construction Procurement prior to bidding on this work item.

Post Installation Pipe Inspection Certification Program

Registration Form

The purpose of this program is to ensure the inspecting contractor can adequately identify and measure distresses and submit the appropriate documentation as per KM 64-114.

Conditions

1. Each **operator** that submits an inspection report to the Kentucky Transportation Cabinet (KYTC) must pass this program as per KM 64-114-12.
2. The program will cover video inspection, deflection measurement inspection, and the successful completion/submittal of the appropriate documentation/forms.
3. The operator is being certified on their particular make/model of video inspection and deflection measurement equipment. If the operator uses more than one make/model for video or deflection inspection under KYTC contract, the operator must be certified on each apparatus. If the operator obtains new inspection equipment the operator must notify KYTC Division of Construction and successfully pass the certification process using the new equipment. If the operator's equipment is upgraded the operator must notify KYTC Division of Construction to determine if re-certification is warranted.
4. The certification will be valid for a period of two years from the date of the official certification award.
5. The cost of the certification is \$750 per operator and the operator's company will be billed following the completion of the certification.



SUBJECT: New Prequalification Work Item
Video & Laser Pipeline Inspection

In accordance with STATE HIGHWAY ENGINEER POLICY # 2008-09 – KYTC POLICY ON PIPE MATERIALS, the following prequalification work item has been established:

J87 - Video & Laser Pipeline Inspection

This work item will be required to conduct camera/video inspection of pipe as outlined in Supplemental Specification 701.03.08 and KM 64-114-08 (Revised 07/18/08).

Contractors wishing to add this work item will need to send a request letter providing details of experience in video and laser pipeline inspection. Contractors will also need to provide certification that their inspection equipment meets the requirements of Supplemental Specification 701.03.08 and Kentucky Method 64-114-08 (Revised 07/18/08).
