A copy of the bid documents may be obtained for a refundable deposit of \$100.00 per set, checks to be made payable to the City of Radcliff. Refunds will be returned only if a responsive bid is received and the plans and specifications are returned in good condition within fourteen (14) days after the bids are opened, otherwise no refund will be due. No drawings will be mailed until receipt of checks. Successful bidders may retain their plans and the deposit amount will be returned.

REQUIRED BID PROPOSAL GUARANTY: All bids shall be accompanied by a bid guarantee of not less than 5% of the total bid.

DBE CERTIFICATION REQUIRED: 4%

The City of Radcliff will receive sealed bids from qualified contractors for the furnishing of all labor, materials and the performance of all work required for the **construction of the pedestrian tunnel on US 31W just north of the intersection of US 31W with Centennial Avenue.**

Prime and DBE Contractors submitting a bid must be pre-qualified by the Kentucky Transportation Cabinet prior to the public reading of the bid on **August 8, 2022** at 10:00 AM Eastern Standard Time at Radcliff City Hall. Subcontractors must be prequalified prior to working on the project. Prime Contractor must be pre-qualified in Grade and Drain. **Please see federal requirements for Disadvantage Business Enterprise (DBE) for additional information.** A list of pre-qualified Contractors and information on the prequalification of Contractors is located at the Kentucky Transportation Cabinet Division of Construction Procurement website as follows:

Specialty subcontractors upon approval from City of Radcliff shall be exempt from being pre-qualified by KYTC.

There will be a mandatory pre-bid conference at City Hall in Radcliff, Kentucky on **July 18, 2022 at 10:00 AM Eastern Standard Time.** It is mandatory for prospective prime contractors to attend.
