Sealed Bids for the construction of the **FOSTER LANE SIDEWALK PROJECT** will be received, by **LINCOLN COUNTY FISCAL COURT** at the office of the **Lincoln County JUDGE EXECUTIVE, Lincoln County Court House, 102 East Main Street, Stanford, Kentucky 40484**, until **3:00 PM** local time on **July 11, 2022**, at which time the Bids received will be **publicly** opened and read. The Project consists of constructing

Stanford, Lincoln County, KY. - Foster Lane SIDEWALK PROJECT

To build 1,332 sq yd of sidewalk and related excavation, curbs, drainage and other items.

Bids shall be on a unit price basis bid items as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is: **Lynn Imaging, Lexington, KY**. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **8:00 to 5:00** and may obtain copies of the Bidding Documents from the Lynn Imaging, Lexington KY as described below.

Bidding Documents also may be examined at **Office of the County Judge Executive** at **office** on Mondays through Fridays between the hours of **[9:00 to 4:00]**; and the office of the Engineer, **AGE Engineering Services, inc.** on Mondays through Fridays between the hours of **[8:00 to 5:00]**.

Bidding Documents may be viewed and ordered online by registering with the Issuing Office at **lynnimaging.com Plan Room**. Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website as "zipped" portable document format (PDF) files. The cost of printed Bidding Documents from the Issuing Office will depend on the number and size of the Drawings and Project Manual, applicable taxes, and shipping method selected by the prospective Bidder. Cost of Bidding Documents and shipping is non-refundable. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

For their bids to be accepted, bidders and Disadvantaged Business Enterprises ("DBE") subcontractors must be prequalified with the Kentucky Transportation Cabinet and possess a Certificate of Eligibility at the time of the bid opening. All other subcontractors must be prequalified when accepting subcontracts.

DBE Certification Required for this project is 2%.

Each bidder must deposit with his bid, security in the amount of 5% of the bid.

NO pre-bid conference will be held.
