The Oldham County Fiscal Court will receive sealed Bids for the KY 1793 Sidewalk Project until 10 A.M., local time, Tuesday, March 5, 2019, at the office of the County Judge Executive at 100 West Jefferson Street, Suite 4, LaGrange, Kentucky 40031. The Bids will be publicly opened and read aloud during the Oldham County Fiscal Court meeting, which takes place at 2 P.M., Eastern Daylight Time.

The Work includes the construction of approximately 793 feet of concrete sidewalk along the north side of KY 1793, between Ridgetop Drive and Ridgeview Drive, approximately 1.75 miles north of US 42 near Goshen, in Oldham County.

Bids are to be addressed to the Oldham County Treasurer Office, Attention: Melissa Horn, County Treasurer, 100 West Jefferson Street, Suite 4, LaGrange, Kentucky 40031 and shall be marked "KY 1793 Sidewalk Project."

Bidding Documents may be reviewed and paper copies may be obtained from the Issuing Office which is Strand Associates, Inc.[®], 325 West Main Street, Suite 710, Louisville, Kentucky 40202, (502) 583-7020. A nonrefundable fee of \$175 will be required (shipping and handling fees included). Overnight mailing of Bidding Documents will not be provided.

All Bidders submitting a sealed Bid shall obtain the Bidding Documents from QuestCDN.com or from Strand Associates, Inc.[®].

Bidders who submit a Bid must be a Plan Holder of record at the Issuing Office. Bids from Bidders who are not on the Plan Holders List may be returned as not being responsive.

Plan Holders are requested to provide an e-mail address to receive addenda and other information electronically. Plan Holders are requested to designate whether they are a prime contractor, subcontractor, and if they want this information posted on the project Plan Holders List.

Contractor shall submit entire Project Manual when submitting Bid. No Bid will be received unless it is accompanied by a bid bond equal to at least 5 percent of the maximum Bid, payable to the Oldham County Fiscal Court as a guarantee that after a Bid is accepted, Bidder will execute and file the Agreement and 100% Performance and Payment Bonds within 15 days after the Notice of Award.

The Oldham County Fiscal Court reserves the right to reject any or all Bids. All Bids shall remain subject to acceptance for 60 days after the time set for receiving Bids.

Contract award shall be made based on the lowest responsive, responsible Bid.

Construction contractors and DBE subcontractors must be prequalified by the Kentucky Transportation Cabinet (KYTC) and possess a Certificate of Eligibility at the time the bid is submitted. All other subcontractors must be prequalified when accepting subcontracts. A list of prequalified contractors and information on the prequalification of contractors is located at the KYTC Division of Construction Procurement Web site at <http://transportation.KY.gov/contract/prequal/>.

This Project is a federal project subject to the requirements of the Federal-Aid Highway Program. Bidders shall comply with the federal wage rate requirements for this Project. Project will follow Kentucky Standard Specifications for Road and Bridge Construction 2012.

The Disadvantaged Business Enterprise (DBE) goal established for this project is 9.1 percent. Bids submitted that do not include certification of DBE participation will not be read publicly.
