- (1) Leveling and wedging to be used as directed by the Engineer to perform repairs while the asphalt base has traffic placed upon it.
- (2) See guardrail summary for location.
- (3) To be used as directed by the Engineer to construct embankment at approx MP 14.7 to protect the pedestrian ramp.
- (4) For reshaping the shoulders after constructing new shoulder pavement and the installation of guardrail using suitable material removed from the shoulders during trenching operations as directed by the Engineer.
- (5) LT U.S. 421 MP 15.72 const. Sidewalk ramp Type 3 Condition 1 with 8 SQYD Sidewalk-4 IN Concrete and 9 SF detectable warning.
- (6) LT U.S. 421 MP 15.74 const. Sidewalk ramp Type 1 with 6 SQYD Sidewalk-4 IN Concrete and 8 SF detectable warning.
- (7) To replace existing pavement marking in the westbound driving lane of KY 70.
- (8) Removal of existing pavement markers will be considered incidental to milling and texturing.
- (9) To be used to excavate the shoulders where the existing 3' wide paved shoulders are being widened to 10' paved shoulders.
- (10) To be used as directed by the Engineer to repair cracks and damage to curb box inlets.
- (11) For repairing washouts on the shoulders. See drainage summary for details. Any excavation and fabric-geotextile class 2 is incidental to the channel lining.
- (12) The Contractor shall contact District 11 Traffic for the removal of the existing signal equipment and radar sensor placement. The equipment is to be installed at the U.S. 421 Entrance to Woodland Plaza shopping Center (M.P. 14.739), the U.S. 421/KY 72 intersection (M.P. 14.966), and the U.S. 421/Main St. intersection (M.P. 15.127).
- Install Radar Presence Detector Type A shall consist of installation of a pole mounted radar presence sensor, sensor mounting bracket, sensor cables, interface boxes, lead-in cable, connectors (furnished by Contractor), and controller interface assembly. Radar Presence Detector Type A bid item shall include all labor required to provide a functional detection system. Radar Presence Detector Type A shall be installed and wired in accordance with the manufacturers instructions. After the detector is installed and before the detector is powered on, the Contractor shall coordinate with District Traffic Division's representatives to schedule a time to perform the detector setup. The Contractor shall double check to verify that all wiring is correctly installed and connected before scheduling the setup work. Representatives from KYTC and/or the manufacturer or sales representative will assist with setup and calibration. The Contractor shall provide a bucket truck and operators at this time for final aiming of the sensors. The Contractor shall provide individuals capable of operating the setup software and learning the setup process so that future installations may be completed without assistance from others.
