Special Note for Road Closure

The contractor shall notify the Resident Engineer two (2) weeks prior to actual closing of the road, from the start to the closure of the road. The contractor has forty-five (45) calendar days to open the new structure to traffic with all safety features in place. Liquidated damages at the contract rate will be assessed if the new structure is not opened to traffic at the end of forty-five (45) calendar days.

The road closure can not take place until Mercer County schools begin summer vacation.

Unless otherwise approved in writing, by the Resident Engineer, maintenance of traffic shall be accomplished as follows: the contractor shall close KY 1987 within the project limits but must provide reasonable access to all parcels at all times.

SPECIAL NOTES FOR LIQUIDATED DAMAGES

Contrary to the current Standard Specifications for Road and Bridge Construction, Section 108.09, if the contractor fails to reopen KY 1987 to traffic, prior to August 1, 2008, liquidated damages will be assessed at the rate of \$1,000 per day for each calendar day that the road is not opened to traffic subsequent to and including that date. All safety devices also must be completed prior to opening the roadway, and removal of the contractor's equipment. Liquidated damages for completion of all other work necessary to complete the project shall be assessed in accordance with the current Standard Specification for Road and Bridge Construction, Section 108.09.

CERTIFICATION OF BID PROPOSAL / DBE

We (I) propose to furnish all labor, equipment and materials necessary to construct and/or improve the subject project in accordance with the plans, the Transportation Cabinet's Standard Specifications for Road and Bridge Construction, current edition, special provisions, notes applicable to the project as indicated herein and all addenda issued on this project subsequent to purchase of proposal.

We (I) acknowledge receipt of all addendum(s) (if applicable) and have made the necessary revisions to the bid proposal. We have considered all addendum(s) in the calculation of the submitted bid and applied the updated bid items, which are included.
