Special Note for Completion Date & Liquidated Damages

I. COMPLETION DATE

The ultimate fixed completion date for this project will be May 31, 2024. Liquidated Damages for failure to complete the project on time will be assessed following Section 108.09.

The intermediate fixed completion date for this project will be November 15, 2023. All newly constructed roadway work except the final asphalt surface, permanent striping, and rumble strips, shall be completed, and the newly constructed roadway fully open to traffic, by the intermediate fixed completion date of November 15, 2023. Liquidated Damages for failure to complete the project on time by the intermediate fixed completion date will be assessed following Section 108.09.

II. LIQUIDATED DAMAGES

In addition to the requirements of Section 108.09, the Department will assess Liquidated Damages in the amount of **\$1,000** per hour for each hour, or fraction of an hour, for any and all lane closures that are in place beyond the time frame(s) noted in the Traffic Control Plan and approved by the Engineer.

Contrary to Section 108.09, Liquidated Damages will be assessed regardless of whether seasonal limitations prohibit the Contractor from performing work on the controlling operation.

Trees and/or bushes that are 5 inches or greater (diameter at breast height) shall not be cut or trimmed between June 1st and July 31st. Any trees and/or bushes that are cut or trimmed between June 1st and July 31st will NOT receive payment at the contract unit price. Furthermore, failure to adhere to these restrictions shall result in Liquidated Damages in the amount of **\$391.50** per affected tree. Activities that are a part of this contract that do not involve the initial trimming and/or cutting of trees and/or bushes will be permitted under the ultimate fixed completion date.

Contrary to Section 108.09, Liquidated Damages will be assessed for the months of December through March.

All liquidated damages will be applied accumulatively.

All other applicable portions of Section 108 apply.
