

#### **Abstract**

This project involves the replacement of the bridge on I-264 (Georgia Davis Powers Expressway) over the P&L Railroad between Campground Road and KY 1934 (Cane Run Road). The existing structure will undergo a full replacement of all major structural elements to improve safety and operational efficiency. The bridge replacement project will be completed while maintaining traffic on I-264. No residential properties will be impacted, but traffic impacts are possible on I-264 during construction. A public survey was conducted to gauge the impact and concerns of the surrounding community. The survey was open from January 16, 2025 – February 16, 2025 and received 21 responses. The following is a compilation of the responses received including graphic representations where applicable.















Which of the following best describes your employment status? (Check all that apply)



What languages are spoken within your household? (Check all that apply)


