You may provide the form to a Team member tonight or mail it in the postage-paid envelopes available at the registration table. All comments are to be submitted within fifteen business days, or by July 21, 2015.

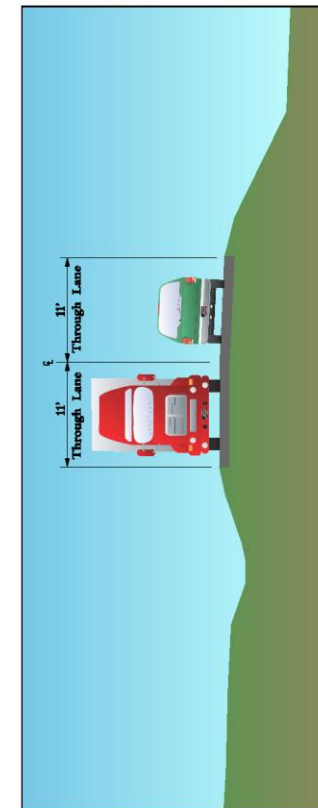

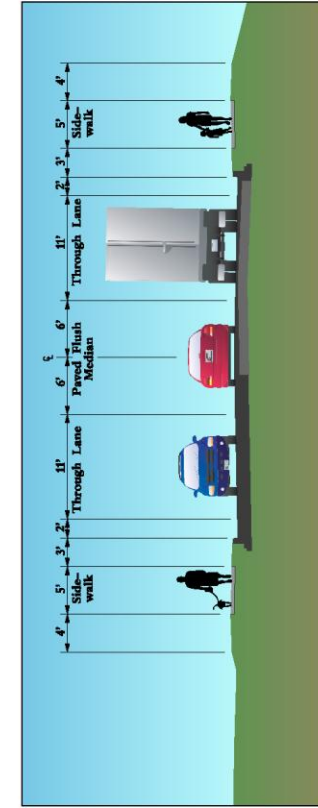

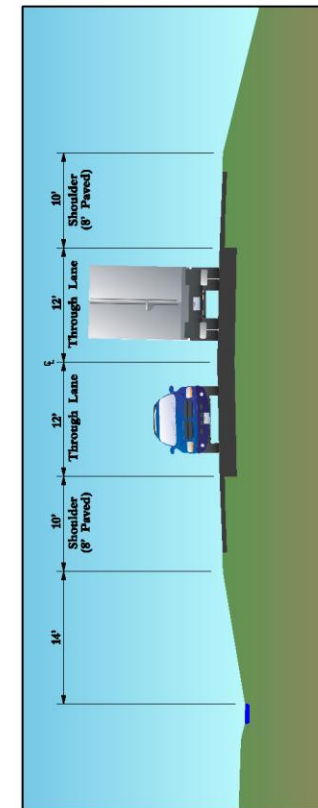
# KY 79 TYPICAL SECTIONS



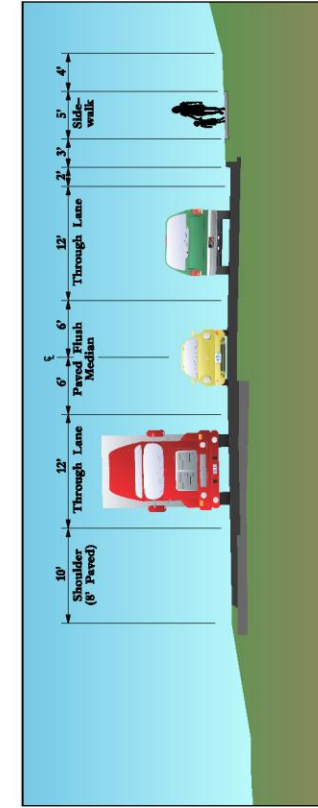
EXISTING TYPICAL SECTION
