Tonight's public meeting is an opportunity for the Kentucky Transportation Cabinet and their Design Team to obtain valuable insight from the general public relative to the proposed project. The purpose of this project is to improve the sight distance, shoulders and create a roadside clear zone for motorists' safety. Two proposed alternates will be presented and can be seen at the display stations.

Alternate No. 1

- Length = 6.25 miles
- Reconstructed along north side of existing U.S. 460
- Estimated right-of-way - 102 acres
- Affects 66 parcels

Alternate No. 2

- Length = 6.36 miles
- Reconstructed along south side of existing U.S. 460
- Estimated right-of-way - 106 acres
- Affects 66 parcels



