### Traffic Impact Report for June 20 through June 24

*(Serving Allen, Barren, Butler, Edmonson, Logan, Metcalfe, Monroe, Simpson, Todd, Warren Counties)*

**BOWLING GREEN, Ky.** (June 17, 2016) – The expected traffic impacts in District 3 for June 20 through June 24 are listed below. All work is subject to change.

#### Butler County

- **KY 949 Penrod Road-** Guardrail will be installed from Leamon Hunt Road, extending approximately 1400 feet north. Motorists should anticipate a one lane roadway controlled by flaggers

#### Barren County

- **KY 2189 Glasgow Park City Road** – Contractors will continue paving operations and constructing shoulders as part of a roadway safety enhancement project that will improve roadside features from U.S. 31-W to U.S. 68. Flaggers will be present to maintain traffic through the work zone.
- **U.S. 68/ KY 80 New Bowling Green Road** – Contractors continue earthwork operations as part of a project that will incorporate a turn lane at the Barren County Livestock Market at mile point 9.6. Flaggers will be present to maintain traffic through the work zone.
- **KY 90 Happy Valley Road** - The bridge over Beaver Creek near mile point 8.3 on KY 90 in Barren County is down to one lane controlled by a temporary traffic signal. The maximum lane width open to traffic is 12 feet. The lane restriction is expected to be in place for approximately four weeks while a contractor conducts bridge deck maintenance. Motorists can expect delays at the bridge and need to use caution while in this area.
- **KY 90 Burkesville Road.** - The bridge over Louie B. Nunn Parkway near mile point 11.16 on KY 90 in Barren County will be reduced down to one lane for each direction of travel. The maximum lane width open to traffic is 11 feet. The lane restriction is expected to be in place for approximately six weeks while a contractor conducts bridge deck maintenance. Motorists can expect delays at the bridge and need to use caution while in this area.
- **KY 1324 Temple Hill Road** – Contractors will continue working on a resurfacing project from the Monroe County line extending northwest to KY 63. Flaggers will be present to maintain traffic through the work zone.

## Edmonson County

- **KY 238 Big Reedy Road** - Contractors will continue working on a resurfacing project from KY 259 mile point 0 to Huff Ridge Road mile point 1.8. Flaggers will be present to maintain traffic through the work zone.
- **KY 1015 Union Light Road** - Contractors will continue working on a resurfacing project from KY 728 mile point 0 to the Hart County line at mile point 4.3. Flaggers will be present to maintain traffic through the work zone.

## Logan County

- **Russellville Southern Bypass**- Excavation activities will continue on the Russellville Southern Bypass just east of U.S. 431 between Country Club Boulevard and Clematis Road. Motorists can expect short impacts while the contractor is in this area.
- **KY 591 Prices Mill Rd** – This road is closed at mile point 10.820 due to a culvert being washed out from extremely heavy. A detour is in place which utilizes KY 765, State Line Road, and C Gore Road. A contractor will continue work to replace the culvert this week. This project is expected to be completed by June 30.



- **KY 664**- A bridge project on KY 664 in Logan County closed a section of the roadway near Berea Church Road and created a detour. The detour utilizes U.S. 431 and KY 663. The closure is expected to last until July 27.



## Metcalfe County

- **KY 163 Tompkinsville Road** - Contractors will continue working on a bridge replacement project over Black Rock Creek near mile point 8.4. The second phase of construction will occur along the existing roadway and bridge. Traffic has been switched to a temporary traffic diversion which will remain until the existing bridge is replaced. Motorists should exercise caution through this area and observe the reduced speed limit. Motorists should be prepared for occasional flagging operations as construction traffic enters and exits the project.

### Monroe County

- **KY 1520-** Crews will be present beginning the middle of next week resurfacing from the intersection of KY 1049 to Metcalfe County line. Flaggers will be present and traffic be down to one lane during re-surfacing. The project is expected to be completed by the end of the week.

### Simpson County

- **U.S. 31-W-** Crews continue placing roadway embankment for the U.S. 31-W widening project. Most this work will be done off the roadway and have little impact on motorist traveling the area. Utility work will also continue. The speed limit through this project has been lowered to 45 mph.

### Todd County

- **KY 181** – North Main Street from Elkton Courthouse to North of bridge over Elk Creek. North Main Street is closed to allow a contractor to remove and reconstruct the bridge over Elk Creek. A signed detour will be in place which utilizes U.S. 68x, Elk Fork Road and U.S. 68.
- **KY 890** Rabbit Ridge Road- Culvert pipe extensions and embankment construction will be taking place from KY 107 extending north to the Muhlenberg County line. Motorists should anticipate a one lane roadway in portions of this 4.2 mile section, which will be controlled by flaggers.

### Warren County

- **Interstate 65 to U.S. 31-W Connector-** Crews continue work on the connector project. Most work is being done off the roadway, but motorists need to be aware of construction vehicles crossing on U.S. 68. Construction traffic is also expected to cross Kelly Road.
- **Kelly Road-** Kelly Road will be closed while work on the I-65 to U.S. 31-W connector continues. There will be a signed detour route. The closure is expected to start July 5.
- **U.S. 231 from Ivy Farm Street extending south to U.S. 31-E-** Crews will begin preparations to resurface this portion of the roadway. There will be intermittent lane closures along these routes to perform the work between the hours of 7 a.m. and 7 p.m. This project is expected to be completed by the end of June.
- **KY 2665 Glen Lily Road-** Resurfacing between U.S. 68 and Main Street is expected to begin this week. The contractor will have lane closures between the hours of 6 a.m. to 6 p.m. This will include sidewalk ramp upgrades and resurfacing the route. This job is expected to be complete by August 5.
