This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain/floodway. FEMA has determined that the only practicable alternative is to fund the repairs of road, already located within the floodplain/floodway prior the event.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

Proposed Work and Purpose: Applicant will utilize force account labor, equipment, materials and contracts for road repairs to District 5 – Bullitt County : Remove and replace of asphalt road surface, dense grade aggregate road base and gravel sub-base, excavate of embankment material, replace of granular embankment material, and install of geotextile fabric type, install of shotcrete embankment, guard rail, and guard rail post. Repairs include following the requested Granular Embankment methods of repair.

Project Alternatives: The following alternatives were considered: (1) Relocation of the facilities outside the floodplain- There are no practicable alternatives to locating the proposed actions outside the floodplain. The damages to the facilities are limited in scope. The cost of relocation would likely outweigh the cost to repair the damages at the current locations. (2) No action alternative - This alternative is not feasible as the repairs are necessary to ensure that the road remains operational and must be in the current location to perform its designed function. Road is the only community access for ingress/egress, services and emergency.
