

**FINAL PUBLIC NOTICE**

The Federal Emergency Management Agency (FEMA) has received the subgrant application for Kentucky Department of Transportation, District 5 Spencer County - KY 2885 MP 5.318. Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published Wednesday , May 9, 2018 for DR-4361 Severe Storms, Flooding, Landslides, and Mudslides, Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain/floodway. FEMA has determined that the only practicable alternative is to fund the repairs of road, already located within the floodplain/floodway prior the event.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

**Proposed Work and Purpose:** Kentucky Department of Transportation will utilize contract and force account for soil nail method of embankment and roadway repair to KY2885: Remove and replace of asphalt, crushed aggregate road base, install of soil nail wall, and excavate and backfill embankment material. Repairs include soil nail technology as method of repair.

**Project Alternatives:** The following alternatives were considered:  
(1) Relocation of the facilities outside the floodplain– There are no practicable alternatives to locating the proposed actions outside the floodplain. The damages to the facilities are limited in scope. The cost of relocation would likely outweigh the cost to repair the damages at the current locations.  
(2) No action alternative - This alternative is not feasible as the repairs are necessary to ensure that the road remains operational and must be in the current location to perform its designed function. Road is the only community access for ingress/egress, services and emergency. With the -no action alternative-, continued negative impacts to the facilities may be experienced
