The Kentucky Transportation Cabinet has scheduled a public meeting for the proposed roadway reconstruction project of US-60 from the previous reconstruction project at rock crusher curve to the I-64 interchange at exit 161. This meeting will be open house format, meaning that interested parties may attend any time from 5:00 PM to 7:00 PM, Thursday, December 7, 2023, at the Carter County Career and Technical Center. There will be a brief 5-to-10-minute project overview presentation tentatively scheduled to start at 5:30 PM.

The purpose of this meeting is to gather information from the public and answer questions about the US-60 roadway project. The goal of the US-60 project is to provide a more consistent roadway by improving the existing roadway geometrics and widening the driving lanes/shoulders. Anyone having an interest in this project is welcome to attend. Transportation Cabinet representatives and their consultant, Palmer Engineering will be available to receive comments and respond to questions. In addition, information concerning Section 106 of the National Historic Preservation Act will be available for any interested in signing up for this important process.

Both written and oral statements will be accepted at the meeting. A tape recorder will be made available for those who desire to make oral statements, and a comment sheet will be distributed to make it more convenient to provide written comments. Written statements will be accepted at the meeting and for a period of 15 days after the Public Information Meeting. Box 347, Flemingsburg, KY 41041, or returned using the postage-paid envelope provided with the comment sheet. All recorded and written statements will become part of the official record.
