The Kentucky Transportation Cabinet (KYTC), District 10 will hold a public informational meeting for the proposed US 460 improvement project on Jan. 25 at the Botts Early Learning Center (formerly known as Botts Elementary School) in Denniston, Menifee County. This section of the US 460 improvement project begins at Denniston, Menifee County (mile point 15.23) and ends at a recently reconstructed section in Morgan County (MP 0.7). The project, as planned, will improve highway safety and operation, correct geometrics, and enhance regional connectivity along this highway corridor.

The purpose of this meeting is to afford interested persons the opportunity to become better informed and to express opinions concerning the project. The meeting will begin at 5 p.m. and will end at 7 p.m. The meeting will be informal, where attendees can review exhibits and other pertinent information and ask questions or discuss the project with KYTC team members. Handouts and comment sheets will be distributed at the meeting. Comment sheets can be filled out and submitted to KYTC representatives at the meeting or by mail until Feb. 8, 2024.

The project is in the preliminary design phase. Right-of-way acquisition and construction dates have not yet been established for the project. All public comments will be reviewed and considered by KYTC.
