

PUBLIC INFORMATIONAL MEETING ANNOUNEMENT THURSDAY, AUG. 16, 2018 (5 - 7 PM) MENIFEE COUNTY HIGH SCHOOL CAFETERIA

KYTC ITEM NO. 10-372.00 & 10-373.00 KY 1274, MENIFEE COUNTY

The Kentucky Transportation Cabinet (KYTC) District 10 will hold a public informational meeting for the proposed KY 1274 rockfall/slope improvements project on Thursday, Aug. 16 at the Menifee County High School cafeteria in Frenchburg. The first section of the KY 1274 rockfall/slope improvements project begins 0.8 mile east of the Long Bow Boat Ramp and ends just west of the intersection of Big Woods Road. The second section of the KY 1274 rockfall/goe improvements project begins a mile south of the Menifee County/Rowan County line and ends just south of the Park and Ride facility next to the county line. The project, as planned, will dramatically reduce the rockfall hazard, improve highway safety and operations along this highway corridor.

The purpose of this meeting is to afford interested persons the opportunity to become better informed and to express opinions concerning the project. The meeting will begin at 5 p.m. and will end at 7 p.m. The meeting will be informal, where attendees can review exhibits and other pertinent information and ask questions or discuss the project with KYTC team members. Handouts and comment sheets will be distributed at the meeting. Comment sheets can be filled out and submitted to KYTC representatives at the meeting ov by mail until Aug. 30.

The project is in the preliminary design phase. Right-of-way acquisition and construction dates have not yet been established for the project. All public comments will be reviewed and considered by KYTC.
