

“Acusensus” Automated Work Zone Enforcement Camera System:

- KSP has worked directly with KYTC (Director John Moore) since mid-July to evaluate multiple vendor options to move forward Kentucky's lifesaving HB664 Work Zone legislation codified within KRS 189.2327 as amended June 27, 2025.
- KYTC has contracted Acusensus as the vendor best meeting the requirements established by the newly established WZ legislation.
- KSP provided direct input to ensure LE needs were met to ensure smooth deployment of the selected vendor's equipment. KSP input identified the need for Acusensus to include a certification with every validated enforcement action to ensure Kentucky LE had the necessary equipment certifications to successfully present court defense of any citations issued.
- The daily working certification of each Acusensus Automated Work Zone Enforcement Camera System is critical, in that it also ensures Kentucky's motoring public the equipment being used to enforce this life saving legislation is accurate.

- These sites have been utilized for testing of the AWZE systems by KSP to ensure operability and to identify any issues requiring resolution prior to becoming fully operational.
- Training of forty (40) KSP Post Trainers was completed on October 13, 2025, with these trainers returning to their respective KSP Post to begin training of field troopers and “Live Testing” of the deployed systems. This testing quickly identified an unforeseen information technologies (IT) issue that required immediate system shut down and the discontinuation of KSP training on October 15, 2025.
- A working resolution was developed by Acusensus IT Staff working in direct coordination with KSP IT Staff to correct a data sharing issue which was placed under further testing by a small group of KSP to ensure the “patch” was effective.
- Successful resumption of Training and Testing was directed on October 28, 2025, with KSP coordinating with Acusensus and KYTC for Live Enforcement to begin at 07:00 hours on October 31, 2025.




