Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice. **If swallowed:** Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**GENERAL:** MAXIMIZER is a combination of superior paraffinic oil and surfactant, designed especially for use with pesticide spray programs. MAXIMIZER may be used with products registered for: agricultural, citrus, forestry, industrial, municipal, non-crop land, ornamentals, rights-of-way, tree crops, turf and other uses.

**DIRECTIONS FOR USE:** READ ALL DIRECTIONS AND NOTICE. In the treatment of new varieties or highly inbred lines, a test area is suggested. DO NOT use MAXIMIZER in sprays applied during periods of extreme high or low temperatures or humid conditions. MAXIMIZER may be applied by ground, aerial or CDA equipment. Some pesticides have stated adjuvant use rates. In all cases the pesticide manufacturer's label should be consulted regarding specific adjuvant use recommendations and that rate followed. Do not add adjuvant at a level that would exceed 5% of the finished spray volume.

**GENERAL USE RATE:** 1 to 8 pints per acre. Follow label of pesticide being used.

**MIXING:** Fill spray tank 1/2 full of water, add the desired amount of herbicide and continue filling. Add correct amount of MAXIMIZER last and continue agitation.

**Environmental Hazards:** Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment washwaters.

### STORAGE AND DISPOSAL

**STORAGE:** Store in cool, dry place. Store in original container. Keep tightly closed. Do not reuse empty container. If stored below 20°F (-6°C) for an extended period, product may become cloudy and thicken. Raise temperature above 32°F (0°C) and product will return to clear, fluid state.

**DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
