Pavement Markings Inspector Qualification

Candidates who successfully complete this exam challenge will be qualified to inspect pavement markings on Kentucky projects until the spring of 2022 when classes are offered again. Candidates will be tested on the appropriate use of the LTL-X Retroreflectometers and retroreflectivity requirements of various pavement marking materials currently used on construction projects. Current Specifications, Kentucky Methods and other pertinent information governing the evaluation of pavement markings will also be on the exam. Candidates will be required to successfully complete both a written and practical exam to be qualified as a Pavement Markings Inspector.
