Welcome and Introductions:

Jeremy Edgeworth provided general housekeeping reminders for the virtual meeting after which the meeting was turned over to the Chair to conduct. The Chair welcomed all in attendance and all attendees introduced themselves.

Public Comment Period:

The Chair invited all attendees to make comments. No public comments were made.

Presentation of Minutes from January 7, 2021

The minutes of the January 7, 2021 meeting were presented and subsequently unanimously approved on motion of Greg Pritchett, seconded by Matt Yates.

Update on Status of Open and Closed KRI projects

Jeremy Edgeworth presented a PowerPoint presentation of open and closed projects and invited representatives from the Riverports to discuss the status of their projects.

- Matt Yates (Louisville Riverport)-Riverport Rail Tie Replacement #6-Project replaced 1,900 ties to hold gage of 13 miles of track owned by Riverport. Condition of track has caused CSX shutdowns of service.
 Work has been completed, left over funds have been transferred to Rail Tie Replacement #7 project, project has been closed.
- Greg Pritchett (Henderson Riverport)-Forklift Project- Project purchased a new 30,000 lb capacity
 forklift to replace the forklift currently being rented. Forklift has been delivered. Truck hopper is also
 being replaced and railcar belt conveyor constructed to use up remaining funds. Truck hopper has
 been completed, rail car belt conveyor has been delivered, awaiting assembly and testing.
- Billy Ray Coursey (Eddyville Riverport)-Sheet Pile Shoring Walls Project-Project will drive sheet piling along bank and add embankment backfill material to correct eroded banks near boat repair well/bay.
 Contract has been awarded and construction will begin soon.
- Greg Pritchett (Henderson Riverport)-Mooring Dolphin Replacement Project Project removes 2 damaged mooring dolphins installed in 1980 and installs 2 new mooring dolphins. Contract has been awarded and materials acquired, installation will begin during summer pool.






Henderson Riverport Authority: Forklift Total Cost \$275,000.00 – Awarded \$137,500.00

Status: Forklift delivered; truck hopper completed; railcar belt conveyor completed; project closed.

Project purchased a new 30,000 lb capacity forklift to replace rented forklift, replaced truck hopper and constructed railcar belt conveyor to utilize remaining funds.



Eddyville Riverport and Industrial Development Authority Sheet Pile Shoring Walls Near Boat Repair Bay Project Total Cost: \$219,780.00 – Awarded: \$109,890.00

Status: Construction Completed, project closed.

Project drove sheet piling along bank and added embankment backfill material to correct eroded banks near the boat repair well/bay.



Henderson County Riverport Authority Mooring Dolphin Replacement Project

Total Cost: \$216,000.00 – Awarded: \$108,000.00

Status: Construction completed, project closed.

Project removed 2 damaged mooring dolphins installed in 1980s and installed 2 new mooring dolphins.



Louisville Jefferson County Riverport Authority Riverport Rail Tire Replacement #7 Project

Total Cost: \$191,584.00 plus \$28K from Tie #6 – Awarded: \$95,792.00

Status: Work is 95% done, all ties are in, waiting on tamping.

Proposed project would replace 1,000 deteriorated rail ties and 49 switch ties throughout the port. Plus 21 additional switch ties and tamping & regulating of 1-2 miles of mainline and all turnouts on industrial leads. The rail lines allow CSX, NS, and P&L to service companies in the park.



Paducah McCracken County Riverport Authority River Belt Discharge Chute Refurbishment Project Total Cost: \$32,472.00 – Awarded: \$16,236.00

Status: Chute fabricated and installed, project closed.

Project refurbished the triple pantleg chute to repair third chute to reopen access to concrete storage pad.





Eddyville Riverport and Industrial Development Authority Guardrail Installation at Pit #2 Project

Total Cost: \$96,830.00 – Awarded: \$48,415.00 Status: Construction completed, project closed.

Project installed guardrail along the access ramps to Pit #2.






Eddyville Riverport and Industrial Development Authority Dock Tieback Repair Project

Total Cost: \$253,000.00 – KRI Requested: \$126,500.00

Status: Work is complete, in invoicing phase.

Proposed project would replace corroded tie back rods, install new whalers and steel plates on dock face, grout to fill voids, and install new precast concrete fenders.






Hickman-Fulton County Riverport Authority CAT 950GC Front End Loader Project

Total Cost: \$272,530.00 – KRI Requested: \$136,265.00

Status: Loader delivered, project closed

Project replaced existing 1980 CAT 966C loader that is becoming increasingly difficult to repair due to the age of the machine with a new CAT 950CG.



Louisville and Jefferson County Riverport Authority Construction of Tangent Connection at Loop Project Total Cost: \$469,658.00 – KRI Requested: \$234,829.00

Status: Bids are due June 22

Proposed project would construct 1,775 feet of new track and turnouts to allow rail traffic to bypass loop tracks.



Owensboro Riverport Authority Compact Track Loader Project

Total Cost: \$69,614.00 - KRI Requested: \$34,807.00

Status: Loader delivered, project closed.

Project purchased a new skid steer located on the new spud barge and used to assist new material handler when unloading bulk products.




Paducah-McCracken County Riverport Authority Clamshell Bucket Replacement Project

Total Cost: \$47,250.00 - KRI Requested: \$23,625.00

Status: Bucket delivered, in invoicing phase

Proposed project would replace existing material handler bucket that is experiencing recurring cracks with a new 4.5 cubic yard clamshell bucket.



Eddyville Riverport and Industrial Development Authority Barge Positioning Winch System

Total Cost: \$210,116.00 – KRI Requested: \$105,058.00

Proposed project would install barge positioning winch system that through a remote control will shift a barge when loading/unloading more efficiently and safer than the current tug winch system.



Eddyville Riverport and Industrial Development Authority Laydown Yard Project

Total Cost: \$369,792.00 - KRI Requested: \$184,896.00


Proposed project would grade, clear, and level 3 acres and spread 8 inches dense grade aggregate to create additional port storage capabilities. Install rip rap in necessary areas to prevent further erosion.



Hickman-Fulton County Riverport Authority Dock Dredging Project

Total Cost: \$63,600.00 - KRI Requested: \$31,800.00

Proposed project will dredge a 700 ft. by 30 ft. area around the docks and remove approximately 15,000 cubic yards of material to maintain normal business operations.



Hickman-Fulton County Riverport Authority Mooring Dock Cell Repair Project Total Cost: \$100,000.00 - KRI Requested: \$50,000.00


Proposed project would make repairs to Mooring Cell 3, Mooring Cell 4, and Mooring Cell 6. Includes adding ballast, replacing damaged guardrail and patch plate over open interlock, and installation of pre-tensioned full circumference rolled plate cell band.



Owensboro Riverport Authority Bucket for Liebherr LH 120 Project


Total Cost: \$114,980.00 - KRI Requested: \$57,490.00

Proposed project would replace 12 year old bucket critical for dry bulk handling operation with new bucket ensuring sustainable production during peak season.



Owensboro Riverport Authority Caterpillar 903D Wheel Loader Project Total Cost: \$73,580.00 – KRI Requested: \$36,790.00

Proposed project would replace one of two skid steers used in daily operations with wheel loader with improved emissions, fuel consumption, and higher clearance from bottom of the barge using Statewide Master Agreement.



Owensboro Riverport Authority Grapple for Sennebogen 875 Project Total Cost: \$71,824.00 – KRI Requested: \$39,912.00

Proposed project would replace a currently leased smaller grapple on Sennebogen Material Handler with a larger capacity grapple for a new steel scrap barge loading business segment.



Owensboro Riverport Authority Terminal Facility Asphalt Paving Project Total Cost: \$145,072.00 – KRI Requested: \$72,536.00

Proposed project would resurface and asphalt 57,779 square feet of internal roads to the grain facility and terminal scale house.







Paducah-McCracken County Riverport Authority Bulk Commodity Receiving Hopper Project Total Cost: \$145,442.00 – KRI Requested: \$72,721.00

Proposed project would construct and install new steel hopper and gate system within existing support leg system. Current steel hopper has been relined twice and is currently experiencing metal fatigue.
