Statement of Work


With the help from KPRCM, Maysville-Mason County River Port will be able to purchase equipment and storage to fully utilize our river port. The river port would be using the funds provided to purchase equipment that will allow us to continue our current operations which consist of loading coal ash from the adjacent rail line facility located on the property to the river. With the additional equipment and the increased rail traffic, we will be able to expand our operations to include agricultural transport. Currently our area has a substantial number of farmers that must travel over an hour in order to sell and deliver a wide variety of grains and produce. This Process unfortunately requires them to drive out of the area and often out of the state. By expanding our river port, we could reduce the amount of travel and time away from home for our farmers, reduce the amount of road usage, and receive economic benefits four our city and county. Without this funding we are currently not able to expand our port, and it remains underutilized.

Project Scope

Purchase of equipment. Including Triple Stack Portable Transfer Conveyors, Large Wheel Loader, and a Radial Stacker. Purchase price will be the only cost incurred. Conveyor quote: \$219,550. Loader quote: \$308,697.50. Radial Stacker quote: \$124,275 For a total initial project cost of \$652,522.50. All three quotes are attached to this application.

Project Scheduling and Timing

We intend to purchase the equipment after receiving the grant from the transportation cabinet. Once the purchase is made we will have it brought to our location and begin using the equipment for our next outgoing barge.
