Voluntary Travel IDs now offered in Frankfort for Owen County residents

REAL ID-compliant cards require additional documentation with strict requirements

FRANKFORT, Ky. (Nov. 27, 2019) – The Kentucky Transportation Cabinet (KYTC) is expanding REAL ID-compliant card access to Owen County residents as the agency makes strides to revamp the state's issuance model. Owen County residents who have an existing driver's license, permit or personal ID may visit the KYTC driver's license office at the Transportation Cabinet headquarters in Frankfort to upgrade to a Voluntary Travel ID.

Voluntary Travel IDs are Kentucky's brand of REAL ID-compliant driver's licenses, permits and identification cards accepted for U.S. commercial air travel and restricted federal facility access once federal enforcement begins Oct. 1, 2020. The cards serve as one of several forms of federal identification accepted at airport security checkpoints, military bases and federal buildings that require ID. Other common forms of acceptable identification citizens may choose to use instead of a Voluntary Travel ID include valid passports, passport cards, and military IDs.

"We're proud to expand access to even more Kentuckians as we build upon our trial regional office location in Frankfort," said Department of Vehicle Regulation Commissioner Matt Henderson. "Coming prepared will save applicants valuable time since new federal standards require additional documentation that must meet strict requirements."

Residents applying for a Voluntary Travel ID card version **must present one (1) valid proof of identity**, one **(1) valid proof of social security number** and two **(2) valid proofs of residency** (dated less than 61 days for most documents). Additional documentation may be required if an applicant's name or gender doesn't match on the four proof documents (like a marriage certificate or divorce decree if your names don't match due to marriage or divorce). A detailed list of acceptable documents is available on the Confident Kentucky [website](#). The online IDocument Guide quiz provides a customized list of documents an applicant will need to present. Some acceptable documents have strict requirements (i.e. no photocopies of birth certificates, unexpired documents, non-laminated social security cards).

The Frankfort driver's license office will continue to accept applications from Franklin County, Anderson County, and Scott County residents. Applicants will receive a temporary 30-day document that serves as a driving credential until the permanent card arrives in the mail at the applicant's residence. The KYTC driver's license office is located on 200 Mero St., in Frankfort, Ky. and is open from 8 a.m. to 4:30 p.m. Monday through Friday (offices will be closed November 27 and 28 for Thanksgiving). Only debit and credit cards will be accepted **(no cash or check)**. The Frankfort office is not equipped to serve applicants who require testing or re-testing.

The Owen County Circuit Court Clerk office will continue to serve as the application site for standard, non REAL ID-compliant driver's licenses, permits and personal IDs.

In September, the Cabinet announced the state is undertaking a new approach to offer Voluntary Travel IDs at regional application site locations staffed by KYTC employees, versus the former county-by-county rollout model at Circuit Court Clerk offices. Details about the regional office locations and timeline to open will be shared once finalized. All Circuit Court Clerk offices continue to offer standard driving credentials*.

About the Confident Kentucky Initiative

Confident Kentucky is an initiative of the Kentucky Transportation Cabinet (KYTC) to improve the security of the issuance and production of state-issued driver's licenses, permits and IDs to meet federal REAL ID standards. When REAL ID enforcement goes into effect Oct. 1, 2020, Kentucky driving and ID credentials without a star cutout in a black circle in the upper-right corner cannot be used at airport security checkpoints for U.S. commercial air travel or to visit military bases and federal facilities that require ID (like the White House). Kentuckians 18 years of age or older will need a Voluntary Travel ID **or** another acceptable form of ID (like a passport, passport card, permanent resident card) to fly within the U.S. or access restricted federal locations. Passports are still required for international travel. Voluntary Travel IDs are optional and will continue to be offered after Oct. 1, 2020. Circuit Court Clerk offices will serve as the application site for standard, non-compliant cards and KYTC regional office locations will accept requests for Voluntary Travel IDs*. All Voluntary Travel IDs will arrive in the mail, are available in eight-year lifespans, feature new pricing and require documentation when applying.
