For use in the normal course of business by a legitimate business or its agents, employees, or contractors, but only: (a) To verify the accuracy of personal information submitted by the individual to the business or its agents, employees, or contractors; and (b) If such information as so submitted is not correct or is no longer correct, to obtain the correct information, but only for the purpose of preventing fraud by pursuing legal remedies against or recovering on a debt or security interest against the individual. For use in connection with any civil, criminal, administrative, or arbitral proceeding in a federal, state, or local court or agency or before any self-regulatory body, including the service of process; the investigation in anticipation of litigation; or the execution or enforcement of judgments and orders, or pursuant to an order of a federal, state or local court. For use in research activities and for use in producing statistical reports, if the personal information is not published, redisclosed, or used to contact individuals. For use by any insurer or insurance support organization or by a self-insured entity or its agents, employees, or contractors in connection with claims investigation activities, antifraud activities, rating, or underwriting.
