Section 1. Application Instructions

To Apply for Solid Waste License

Municipal Solid Waste per KRS 224.01-010, Municipal solid waste is defined as “household waste and commercial solid waste”. “Household solid waste means solid waste, including garbage and trash generated by a single and multiple family residences, hotels, motels, bunk houses, ranger stations, crew quarters, and recreational areas such as picnic areas, park and camp grounds, but it does not include tire derived fuel”. Furthermore, “Commercial solid waste’ means all types of solid waste generated by stores, offices, restaurants, warehouses, and other service and non-manufacturing activities, excluding tire-derived fuel and house hold and industrial solid waste”. The application that follows is for municipal solid waste transporters only. For other types of solid waste permits, please contact the EEC Division of Waste Management at (502) 564-6716.

You are required to follow these instructions to complete and mail or deliver this application form including the [License Application](#) (Section 2) and enclose the required fees to the Transportation Cabinet, Division of Motor Carriers, Qualifications and Permits Branch, 200 Mero St Frankfort, KY 40622 (for deliveries and overnight mail). To mail via regular postage please send to: Division of Motor Carriers PO BOX 2007, Frankfort KY 40602.

Enclose a Check or Money Order

You must enclose one check or money order made payable to the “Kentucky State Treasurer” in the amount of the per vehicle fee of \$10 or prorated for the month the vehicle is registered (See chart in Section 4, page 8).

Register your Business or Business Name

Business Organizations Must Register with the Kentucky Secretary of State

If you are a business organization that is required to be registered with the Kentucky Secretary of State in order to do business in Kentucky, you shall complete your registration prior to submitting this application. If you have any questions regarding the registration process please contact your attorney or the office of the Kentucky Secretary of State. Enclose a copy of a certificate of existence from the Secretary of State no more than 30 days old.

Sole Proprietors Must File a Certificate of Assumed Name with the County Clerk

If you are operating your business as a sole proprietor you are not required to register your business name directly with the Kentucky Secretary of State, but you are required to file a certificate of assumed name with the county clerk where you maintain your principal place of business. Complete and record the enclosed [Certificate of Assumed Name for Sole Proprietor](#) (Section 3) then enclose the recorded copy with this application.

Section 1. Application Instructions

Commercial Insurance:

The minimum amount of liability insurance for the transportation of solid waste 18,000 lbs. or less shall be one hundred thousand dollars (\$100,000) for death and personal injury to one (1) person, three hundred thousand dollars (\$300,000) for death and personal injury resulting from one (1) incident, and fifty thousand dollars (\$50,000) for property damage. The minimum amount of liability insurance for the transportation of solid waste more than 18,000 lbs. shall be one hundred thousand dollars (\$100,000) for death and personal injury to one (1) person, six hundred thousand dollars (\$600,000) for death and personal injury resulting from one (1) incident, and fifty thousand dollars (\$50,000) for property damage.

Qualification of Vehicle(s):

- If your company is transporting Municipal Solid Waste from outside of Kentucky into the state, you must provide a "Consent to Service" document with this application. For more information about "Consent to Service", please see KRS 224.43-380. If you need a copy of a blank form, please call (502) 564-1257 or email: qp.dmc@ky.gov.
- Per KRS 174.450, vehicles with a Gross Registered Weight of 10,000 lbs. or less do not need to be added to the Municipal Solid Waste Transporter License. Vehicles over 10,000 lbs., a USDOT number is required, please see:

- Per KRS 138.665, vehicles with a Gross Registered Weight of 60,000 lbs. or greater are required to have a KYU license, please see Form TC 95-1:

Section 1. Application Instructions

Applying to Add Additional Vehicles under an Existing License

You may use this application form to add additional vehicles to an existing license. If using this application to request additional vehicles under your license you shall submit the [License Application](#) (Section 2), the [Vehicle Qualification form](#) (Section 4), listing information for each additional vehicle, and enclose a check or money order made payable to the “Kentucky State Treasurer” in an amount equal to the prorated \$10 per qualified vehicle fee (See chart in Section 4, page 8).

License Issuance

For your security, if the Department of Vehicle Regulation approves your application for a solid waste license or for additional vehicles, the license and vehicle credentials issued by the department will be mailed by first class mail to your mailing address on file with the Department. Alternatively, the credentials may be delivered in person to either a Sole Proprietor or an authorized officer or registered agent of the Corporation, Partnership, or Limited Liability Company listed with the Kentucky Secretary of State whose identity can be verified. You may request overnight or other expedited mail delivery by submitting with this application a corresponding prepaid envelope addressed to your mailing address on file.
