DEFINITIONS

Manufacturer – Any person, partnership, firm, association, corporation, or trust, resident or nonresident, who manufactures or assembles new motor vehicles, or imports for distribution through distributors of new motor vehicles, or any partnership, firm, association, joint venture, corporation, or trust, resident or nonresident, which is controlled by the manufacturer.

“Manufacturer” includes:

1. **Motor Home Manufacturer** – Any person other than the manufacturer of the chassis of a motor vehicle who, prior to the retail sale of the motor vehicle, performs modifications on the chassis that result in the finished product being classified as a motor home. A motor home is a new vehicular unit designed to provide temporary living quarters built into an integral part of or permanently attached to a motor vehicle chassis, and which has at least four (4) of the following facilities:
 - (a) Cooking with on-board power source;
 - (b) Gas or electric refrigerator;
 - (c) Toilet with exterior evacuation;
 - (d) Heating with on-board power source and/or air conditioning separate from the vehicle engine;
 - (e) A portable water supply system including a faucet, sink, and water tank with an exterior service connection; or
 - (f) A separate 110-125 volt electric power supply.
2. **Distributor** – Any person, firm, association, corporation or trust, resident or nonresident, who in whole or in part offers for sale, sells, or distributes any new motor vehicle to new motor vehicle dealers, or who maintains factory representatives, or who controls any person, firm, association, corporation, or trust, resident or nonresident, who in whole or in part offers for sale, sells, or distributes any new motor vehicle to new motor vehicle dealers;
3. **Factory Branch** – A branch office maintained by a manufacturer for the purpose of selling, or offering for sale, new motor vehicles to a distributor, wholesaler, or new motor vehicle dealer, or for directing or supervising, in whole or in part, factory or distributor representatives, and shall further include any sales promotion organization, whether the same be a person, firm, or corporation, which is engaged in promoting the sale of new motor vehicles in this state of a particular brand or make to new motor vehicle dealers.

4. **Factory Representative** – A representative employed by a manufacturer, distributor, or factory branch for the purpose of making or promoting for the sale of his, its, or their new motor vehicles, or for supervising or contracting with his, its, or their dealers, or prospective dealers.
5. **Distributor Branch** – A branch office similarly maintained by a distributor or wholesaler for the same purposes.
6. **Distributor Representative** – A representative similarly employed by a distributor, distributor branch, or wholesaler.
7. **Component Manufacturer** – Any resident person, partnership, firm, association, corporation or trust, who manufactures or assembles components or constituent parts, for inclusion in the final assembly of new motor vehicles, in this state, but is not otherwise involved in the distribution or sale of motor vehicles.
