In February of 2014, Cultural Resource Analysts, Inc. (CRA), personnel completed a cultural historic records review and windshield survey for the proposed I-75 to Mountain Parkway Connector in Clark, Madison, Estill, and Powell Counties, Kentucky. The study was conducted at the request of Parsons Brinckerhoff on behalf of the Kentucky Transportation Cabinet. The objective of the records review and windshield survey was to identify National Register of Historic Places (NRHP) listed, eligible, or potentially significant properties within the study area that should be taken into consideration as project plans are developed. An archaeological study is being conducted by CRA in conjunction with the cultural historic component; it has yet to be completed at the time of publication of this technical memorandum.

CRA personnel completed a records review at the Kentucky Heritage Council (KHC) on February 12, 2014. Six NRHP-listed resources were identified in Clark County (CK 6, CK 21, CK 25, CK 397, CK 439, and CK 597); 15 NRHP-listed resources were identified in Madison County (MA 10, MA 21, MA 23, MA 31, MA 45, MA 52, MA 57, MA 62, MA 196, MA 198, MA 206, MA 224, MA 234, MA 236, MA 481) as well as the Boonesboro Townsite Historic District with contributing resources (MA 1, 2, 3, MA 372 and MA 373). The Boonesborough Fort Site, a National Historic Landmark, is also located in Madison County; although the original fort is no longer extant, the site remains and is part of the Fort Boonesborough State Park. Remnants of Boone Trace, a historic road forged by Daniel Boone in 1775 are evident in Madison County; the Kentucky portion of the road traverses from the Cumberland Gap to Boonesboro. While not listed in the NRHP, the Friends of Boone Trace have plans to nominate the entire Kentucky portion of the road and preserve it as a heritage walking trail. Two NRHP-listed resources were identified in Estill County (ESI 8 and ESI 9) as well as the Irvine Downtown Business District with 32 contributing resources (ESI 3, 6, 8, 10–17, 19-20, and 22-40). No NRHP-listed resources are located within the study area in Powell County. Twenty resources were determined eligible or recommended for listing in the NRHP (CK 389, CK 402-403, CK 414, CK 425, CK 429, CK 472, CK 511-515, CK 520, MA 4, MA 7 [as an additional resource to the Madison County MRA], MA 29, MA 38, MA 239, the Blue Grass Army Depot, and ES 9) and 30 are no longer extant (CK 1, CK 5, CK 34, CK 133-135, CK 137, CK 322, CK 365-369, CK 388, CK 394–396, CK 398–400, CK 518–519, CK 536, a pony truss bridge in Clark County [Bridge # 25-0974-B0088], MA 16, MA 22, MA 42-43, MA 46, and the Wells House); these resources and their statuses can be found in the tables that follow (Tables 3, 5, 7, 9). The remaining previously recorded resources have "undetermined" NRHP statuses according to KHC's database.

A review of surveys and reports on file at KHC revealed several earlier surveys overlapping the current study area and survey corridor. These reports have been assembled into Table 1. The previous reports identified a number of previously recommended NRHP-eligible resources, which have been identified in Tables 3 and 7. The study area consists of two regions: the broad study area and the survey corridor. Only the survey corridor, which traverses parts of Madison County (KY 25 and KY 52), Estill County (KY 52, KY 89, and KY 499), and Powell County (KY 89 and KY 82) was subject to a windshield survey. Sarah Reynolds and Kathy Martinolich of CRA completed the windshield survey on February 20 and 24, 2014, noting the current condition of previously surveyed resources and identifying undocumented resources and assessing them for potential significance. Both individual resources and larger neighborhoods and potential historic districts were assessed during the survey. All previous NRHP-listed resources in the survey corridor (MA 52, MA 45, MA 62, ESI 8, and all contributing resources associated with the Irvine Business District [ESI 3, 6, 8, 10-17, 19-20, 22-40]), appear to maintain the characteristics that made them eligible for NRHP listing. MA 234 was inaccessible and therefore was not assessed. The resources previously recommended eligible for NHRP listing (ESI 42, ESI 62, ESI 75, ESI 77, ESI 78, and ESI 91) also appear to maintain the characteristics that made them eligible. Twelve new individual historic resources and two new historic districts (CRA 1-3, CRA 5-11, CRA 13-14, Waco Downtown District [MA 48, MA 49, MA 50, MA 51, and CRA 4], and Irvine Main Street Residential District [CRA 12]), were identified in the field as potentially significant properties. The remaining resources 50 years of age or older observed in the survey corridor are generally characterized by early- to mid-twentieth-century residences that exhibit common house forms such as I-houses, T-plans, bungalows, front-gable cottages, American Small Houses, and Ranches and have undergone material changes that have diminished or compromised their integrity, so they are unlikely to be eligible for listing in the NRHP.

The attached tables and map detail the extent of the study area and survey corridor and the locations and NRHP-eligibility recommendations of the identified resources. Since the majority of the study area has not been subject to formal cultural historic survey, additional investigations may be required as project plans are developed.
