



We reviewed the proposed preferred alternative for the Ohio River Mega Park Connector Project and while we did not find any rare plants or animals or high quality natural communities within this area, there are several near the site. These include cream wild indigo (*Baptisia bracteata* var. *glabrescens*), hair grass (*Muhlenbergia glabrifloris*), black buffalo (*Ictiobus niger*) and green treefrog (*Hyla cinerea*). We suggest the area be surveyed prior to construction. Also the road will cross several substantial wetlands and streams. All precautions to preserve their quality should be taken. The Kentucky Department of Fish and Wildlife Resources (KDFWR) has received your request for information pertaining to the subject project. The Kentucky Fish and Wildlife Information System indicates that the federally-listed Indiana bat (*Myotis sodalis*), Interior Least Tern (*Sternula antillarum athalassos*), Orangefoot Pimpleback (*Plethobasus cooperianus*), Rabbitsfoot (*Quadrula cylindrica cylindrica*), Pink Mucket (*Lampsilis abrupta*), Sheepnose (*Plethobasus cyphyus*), Ring Pink (*Obovaria retusa*), and Fat Pocketbook (*Potamilus capax*) are known to occur within close proximity to the project site. Further, the eastern portion of the project is within known Indiana bat summer maternity habitat according to the U.S. Fish and Wildlife Service Kentucky Field Office (USFWS). The KDFWR recommends consulting with the USFWS to discuss ways to reduce impacts to the Indiana bat as a result of this project. Tree clearing from October 15-March 31st will likely be recommended to reduce impacts to roosting bats. The state-listed Northern Crawfish Frog (*Rana areolata circulosa*) is also known to occur within one mile of the project site.

Lastly, this project occurs within mussel, fish, lamprey, mammal, reptile, amphibian, and bird Conservation Areas outlined in the KDFWR State Wildlife Action Plan. Impacts to these areas should be avoided to the extent practical as the value to fish and wildlife is obvious and profound. Please be aware that our database system is a dynamic one that only represents our current knowledge of various species distributions.



It appears that the proposed project has the potential to impact wetland habitats. KDFWR recommends that you look at the appropriate US Department of Interior National Wetland Inventory Map (NWI) and the appropriate county soil surveys to determine where the proposed project may impact wetlands. Additionally, field verification may be needed to determine the extent and quality of wetland habitats within the project area. Any planning should include measures designed to eliminate and/or reduce impacts to wetland habitats. If impacts cannot be avoided, mitigation should be properly designed and proposed to offset the losses. KDFWR will recommend, at a minimum, a 2:1 mitigation ratio for any permanent loss or degradation of wetland habitats.

KDFWR recommends that you contact the appropriate US Army Corps of Engineers office and the Kentucky Division of Water prior to any work within the waterways or wetland habitats of Kentucky. Additionally, KDFWR recommends the following for the portions of the project that impact streams:

- Channel changes located within the project area should incorporate natural stream channel design.
- If culverts are used, the culvert should be designed to allow the passage of aquatic organisms.
- Culverts should be designed so that degradation upstream and downstream of the culvert does not occur.
- Development/excavation during low flow period to minimize disturbances.
- Proper placement of erosion control structures below highly disturbed areas to minimize entry of silt into area streams.
- Replanting of disturbed areas after construction, including stream banks, with native vegetation for soil stabilization and enhancement of fish and wildlife populations. We recommend a 100 foot forested buffer along each stream bank.
- Return all disturbed instream habitat to a stable condition upon completion of construction in the area.
- Preservation of any tree canopy overhanging any streams within the project area.

To minimize indirect impacts to aquatic resources, erosion control measures should be developed and implemented prior to and concurrent with construction to minimize siltation into streams and drainages. Such erosion control measures may include, but are not limited to silt fences, staked straw bales, brush barriers, sediment basins, and diversion ditches. Erosion control measures will need to be installed prior to construction and should be inspected and repaired regularly as needed.

The Division of Water has received your request for comments on the subject project. We have reviewed the documentation presented and have noted the following:

- Water and sewer lines are present in the proposed project area and should be considered during design and construction to avoid damage to existing infrastructure or disruption of service. It is also recommended local water/wastewater utilities be contacted to incorporate any proposed lines into the planning process. Local utilities with the potential to be affected by this project include West McCracken County Water District, Paducah Water, and Paducah-McCracken County Joint Sewer Agency.
- A cursory review of the proposed project suggests Individual Water Quality Certification (WQC) may be necessary. KTC should be prepared to reduce and minimize stream and wetland impacts as much as possible. If the stream and wetland impacts, on a cumulative basis, exceed the General Certification conditions, an Individual WQC will be required.

Within the Cabinet, the Commissioner's Office in the Department for Environmental Protection coordinates the review for Kentucky state agencies.

We received your letter dated September 23, 2013 requesting our review of the planning study for the Mega Park Access Road. The following comments are submitted in reference to your project.

Comments from the Division of Waste Management:

All solid waste generated by this project must be disposed at a permitted facility. If asbestos, lead paint, and/or other contaminants are encountered during this project, they must be properly addressed.

Comments from the Division of Water:

Compliance & Technical Assistance Branch:

Assure that all appropriate floodplain, 401/404, and stormwater permits are obtained. Daniel Fraley, Compliance and Technical Assistance Branch, (606) 783-8655, <u>Daniel.Fraley@ky.gov</u>.



Water Quality Branch:

There are no Outstanding State Resource Waters, Wild Rivers, or known Exceptional Waters within the project area. Best management practices shall be utilized to reduce runoff into surface waters. John Brumley, Water Quality Branch, (502) 564-3410, John.Brumley@ky.gov.

Watershed Management:

Kentucky Revised Statute KRS 151.250 provides for exemption for the Department of Highways; therefore, a stream construction permit will not be required. No comment for Water Withdrawal Permitting and Water Management Planning. Julia Harrod, Watershed Management Branch, (502) 564-3410, Julia.Harrod@ky.gov.

If the widening or rerouting crosses any water or monitoring wells, a Kentucky certified driller will need to properly abandon the wells before construction proceeds. If any of the contractors have onsite activities covered under the Groundwater Protection Plan regulation, they will need to develop a Groundwater Protection Plan for those activities. Comments from the Division of Air Quality:

Kentucky Division for Air Quality Regulation 401 KAR 63:010 Fugitive Emissions states that no person shall cause, suffer, or allow any material to be handled, processed, transported, or stored without taking reasonable precaution to prevent particulate matter from becoming airborne. Additional requirements include the covering of open bodied trucks, operating outside the work area transporting materials likely to become airborne, and that no one shall allow earth or other material being transported by truck or earth moving equipment to be deposited onto a paved street or roadway. Please note the Fugitive Emissions Fact Sheet located at http://air.ky.gov/Pages/OpenBurning.aspx.

Regulation 401 KAR 63:005 states that open burning is prohibited. Open Burning is defined as the burning of any matter in such a manner that the products of combustion resulting from the burning are emitted directly into the atmosphere without passing through a stack or chimney. However, open burning may be utilized for the expressed purposes listed on the Open Burning Brochure located at http://air.ky.gov/Pages/OpenBurning.aspx.

The Division would like to offer the following suggestions on how this project can help us stay in compliance with the National Ambient Air Quality Standards. More importantly, these strategies are beneficial to the health of citizens of Kentucky.

Utilize alternatively fueled equipment.

- Utilize other emission controls that are applicable to your equipment.
- Reduce idling time on equipment.

This review is based upon the information that was provided by the applicant. Thank you for the opportunity to provide comments on the above-referenced project. The U.S. Fish and Wildlife Service (Service) has reviewed this proposed project and offers the following comments in accordance with the Endangered Species Act of 1973 (87 Stat. 884, as amended; 16 U.S.C. 1531 *et seq.*) and the Fish and Wildlife Coordination Act (48 Stat. 401, as amended; 16 U.S.C. 661 *et seq.*). This is not a concurrence letter. Please read carefully, as further consultation with the Service may be required.

In accordance with the provisions of the Fish and Wildlife Coordination Act, the Service has reviewed the project with regards to the effects the proposed actions may have on wetlands and/or other jurisdictional waters. We recommend that project plans be developed to avoid impacting wetland areas and/or streams, and reserve the right to review any required federal or state permits at the time of public notice issuance. The U.S. Army Corps of Engineers should be contacted to assist you in determining if wetlands or other jurisdictional waters are present or if a permit is required.

In order to assist you in determining if the proposed project has the potential to impact protected species we have searched our records for occurrences of listed species within the vicinity of the proposed project. Based upon the information provided to us and according to our databases, we believe that the following federally listed species have the potential to occur within the project vicinity. We must advise you that collection records available to the Service may not be all-inclusive. Our database is a compilation of collection records made available by various individuals and resource agencies. This information is seldom based on comprehensive surveys of all potential habitats and thus does not necessarily provide conclusive evidence that protected species are present or absent at a specific locality.

Indiana bat

Part of the proposed project site is located within habitat designated as "potential habitat" for the Indiana bat and part is located within "known maternity" habitat for the species. Based on this, we believe that: (1) forested areas in the vicinity of and on the project area provide suitable summer roosting and foraging habitat for the Indiana bat; and (2) caves, rockshelters, and abandoned underground mines in the vicinity of and on the project area may potentially provide suitable wintering habitat for the Indiana bat. KYTC should address the impacts to the Indiana bat through adherence to the September 6, 2012 Indiana bat Programmatic Agreement between KYTC, FHWA, and the Service.

Federally listed mussels

Freshwater mussels are one of the most imperiled groups of animals in North America. Reservoir construction, siltation, channelization, and water pollution are all factors that have contributed to the decline of our native mussel populations. The runoff from urban areas has degraded the quality of water and the substrate of many streams. As filter feeders, mussels are sensitive to contaminants and function as indicators of problems with water quality. Several species of federally listed mussels are known to occur in the Ohio River in Kentucky. The potential for siltation/sedimentation and contamination should be addressed when evaluating projects that impact streams that flow into the Ohio River.

After research and discussion with the Paducah Transit Authority, OTD has found that there is a great need for an alternative route redirecting traffic from neighborhoods and businesses to the Mega park. The Ohio River Megapark project is a major development in the Paducah area. As mentioned in your letter, it will bring thousands of jobs and will attract tourists. The current road infrastructure is not suitable to accommodate to the projected traffic needs of this project. Currently, the nearest interstate access is on KY 305 (Old Cario Rd). We have reviewed the draft project purpose and need statement and alternatives considered for the Mega Park access road and acknowledge the fact that alternative four, as currently proposed, alleviates concerns to the Natural Resources Conservation Service (NRCS) for potential impacts to existing Wetlands Reserve Program (WRP) easements.

Alternative four, as currently depicted on the study map, does not impact any existing or proposed WRP easements. While NRCS will make every effort to cancel or modify a proposed easement before it closes, modification of an existing easement is an arduous and lengthy process for any entity proposing to modify a WRP easement. The proposed project must be of public benefit, the applicant must mitigate for the impacts, and the modification will only be considered after the applicant has demonstrated that no other practical alternative exists.
