## 1.0 PROJECT DESCRIPTION




Figure 1: Study Area

The Kentucky Transportation Cabinet (KYTC) initiated the *Mayfield Small Urban Area (SUA) Study* in Spring 2020 for the City of Mayfield and surrounding urbanized areas of Graves County, Kentucky. Small urban area studies provide thorough examinations of study area roadways, including analyses of existing and future traffic conditions, and safety related issues intended to identify transportation network needs and potential solutions to efficiently move goods and travelers. Mayfield lies within the Purchase Area Development District (PADD). Illustrated in **Figure 1**, the study covers roughly 41 square miles of land area and study routes include approximately 57 miles of state-maintained and 3 miles of high-volume local routes, defined in **Table 1**. I-69 was excluded from the study.


This report summarizes methodologies and procedures associated with the development of future traffic analyses to support the small urban area study.

## 2.0 DATA COLLECTION EFFORTS

### 2.1 Historic Traffic Volumes

KYTC provided Qk4 with available existing traffic volumes for study area roadways, including truck percentages, K-factors, and peak hour directional distributions as available. Most traffic volumes were collected from 2017 to 2019. To grow this data to 2020 levels, historic traffic counts for each segment were used to determine a growth rate for that roadway section. These growth rates were then used to project the latest KYTC counts to 2020. Using this methodology, a few roadway segment counts showed negative growth for which a growth rate of zero was used for both cars and trucks. The results of this analysis showed historic annual growth rates ranging from 0.0% to 2.16% on study routes, corresponding to the Kentucky State Data Center (KSDC)<sup>1</sup> population data. **Table 2** shows the county's overall population declined from 2010 to 2019 but is projected to steadily grow from 2020 to 2040.

**Table 3** presents annual average daily traffic (AADT) volumes for study roadways for the 2020 Existing condition. Truck percentages were derived from historic counts or assumed from KYTC's 2008 *Traffic Forecasting Report* defaults where unavailable.

## 2.2 Turning Movement Counts




Figure 2: Turning Movement Count Locations

Qk4 collected additional counts in October 2020 at intersections shown on **Figure 2** (page 6). Turning movement counts at major intersections along with recent KYTC counts were used to define existing traffic including daily, AM, and PM peak hour volumes. Twelve-hour Miovision turning movement counts

were conducted, classifying vehicles into one of five categories: motorcycles, cars, buses, single unit trucks, and articulated trucks. Any pedestrians and on-road bicyclists were also recorded.

Unadjusted turning movement counts are presented in **Appendix A**. Turning movement forecasts for the 2020 Existing scenario are presented in **Appendix B** for each of the counted intersections.

It should be noted that the KY 80 extension (Item No. 1-181.5) was under construction while this small urban area study was being prepared, opening to traffic in late 2020. The route forms a southern bypass of the city, represented by the dotted blue line in **Figure 2**. Turning movement counts presented herein were conducted before this segment opened to traffic.<sup>2</sup>

### 3.0 KENTUCKY STATEWIDE TRAVEL DEMAND MODEL

To project future year traffic forecasts, KYTC's Kentucky Statewide Travel Demand Model (STDM), version 19 5961 Master was applied. The year 2020 served as the "existing" baseline scenario. Future year 2045 No-Build and Build forecasts were also developed. The KYTC model runs in TransCAD7, which meshes best with 32-bit software packages and is a 24-hour model, with no time-of-day components.

#### 3.1 KYTSTMv19 Modifications

A traffic analysis zone (TAZ) is a geographical area delineated by state and/or local transportation officials for tabulating traffic-related data, especially journey-to-work and place-of-work statistics. A TAZ usually consists of one or more census blocks, block groups, or census tracts. Per the socioeconomic analyses that Purchase Area Development District prepared for the SUA study, the study area includes or overlaps 17 of 29 total block groups comprising Graves County.




Figure 3: Model TAZ Splits, Before (left) and After (right)

TAZ were split around the city to refine traffic projections, as illustrated in **Figure 3** (page 7). Pink areas highlight zones that were geographically divided. Prior to any TAZ splitting, there were 21 zones within the study area limits for the SUA study. Following the TAZ splitting, there were 35 zones within the study area limits. To the extent possible, zones were divided at major roadways, grouping similar land uses and special traffic generators like industries or schools.




Figure 4: Change in Households by TAZ, 2020 to 2045




Figure 5: Change in Employment by TAZ, 2020 to 2045

Socioeconomic assumptions were adjusted to reflect the revised TAZ boundaries. **Figure 4** (page 8) summarizes anticipated household growth between 2020 and 2045 model scenarios. As shown, an overall decline in households is anticipated, losing about 100 within the study area TAZs over the next 25 years. The largest growth occurs southwest of town. **Figure 5** (page 9) summarizes anticipated changes in employment between 2020 and 2045 model scenarios. As shown, fairly robust employment growth is projected—totaling 560 new jobs distributed among study area TAZs.

<sup>2</sup> District 1 conducted a tube count during 4-6 PM in January 2021. The route carried 697 vehicles during this period, 51% eastbound, with 3.5% heavy truck traffic.

The KY 80 extension was incorporated into the 2045 No-Build model network but no other large-scale regional transportation improvements were assumed.

### 3.2 2045 No-Build Traffic Projections

No-Build model results are summarized for study routes in **Table 4**. No-Build forecast spreadsheets at each counted intersection are included in **Appendix C**.

Existing volumes were held steady for 2045 forecasts on segments having lower future year assignment compared to existing year volumes. On roadway segments showing positive growth, future year model assignments were adjusted using differences and ratios between existing volumes and model assignments. Adjusted future year, model assignments were then averaged to determine future year average daily traffic (ADT) and design hourly vehicle (DHV) volumes for each segment.

## 4.0 BUILD TRAFFIC




Figure 6: Proposed Improvement Concepts

Proposed improvement concepts are shown on **Figure 6** and summarized in **Table 5** (page 13). Twelve small scale spot improvements (Spots A through L) generally represent low-cost improvements largely contained in existing right-of-way—for example, improvements at a single intersection. Seven large scale spot improvements (Spots M through S) represent higher costs and/or longer timeframes for implementation—for example, a new highway connection or improvements along an entire corridor. Additional information on each concept is presented in the study report.

Most recommended improvement concepts were smaller in scale or focused on improving safety leading to minor impacts on routine traffic operations. One build scenario was analyzed within the KSTD: Spot O, widening the KY 121 Bypass to a five-lane rural template between KY 80 and US 45, milepoints 5.499 to 8.940.

Along this section of the KY 121 Bypass, existing (2020) traffic volumes are 7,100 to 12,900 vehicles per day (vpd), operating at LOS D with a 0.36-0.47 v/c ratio based on segment-level calculations using Highway Capacity Software version 7. In the 2045 No-Build scenario, this increases to 9,100 to 16,000 vpd, operating at LOS D-E or 0.44-0.58 v/c. In the 2045 five-lane Build scenario, the bypass carries 9,600 to 16,600 vpd, operating at LOS A-B with a 0.20-0.35 v/c.

Four study intersections lie along the proposed widening. Turning movement forecast sheets at each are presented in **Appendix D**.
