## INTRODUCTION AND STUDY AREA

The AA Highway Improvements Study was initiated by the Kentucky Transportation Cabinet (KYTC) through the 2018 – 2020 Statewide Planning Services Contract to identify and evaluate potential improvement concepts to improve overall safety and operational performance of the AA Highway (KY 9 / KY 10). Through the application of a data-driven safety and operations analysis, potential improvement concepts will be identified, evaluated, and prioritized to complete a comprehensive transportation improvement plan for the corridor. The study area incorporates KY 9 from the Campbell / Pendleton County line to Grayson (KY 1), and KY 10 from Vanceburg to US 23 in Greenup County (total of approximately 120 miles). The study area is presented in **Figure 1**.

The current project phase is a scoping study. Traffic impacts will be evaluated for the existing conditions (2020) and future year (2045). No distinction is made between No Build and Build volumes for the mainline forecasts as differences are not expected to alter design decisions. For reference, the Design Year was determined to be 2045 per guidance from the scoping meeting (September 20, 2019 scoping meeting).


This document summarizes the AA Highway traffic forecast procedure and presents the following types of forecasts:

- 2020 AADT and DHV
- 2045 AADT and DHV
- 2020 / 2045 AADTT
- Select Intersection 2020 / 2045 AM and PM Turning Movement Volumes

Forecasts were developed for the mainline segments initially. Following the existing conditions analysis and identification of potential improvement concept locations, specific intersections were identified for turning movement counts. The locations were chosen where there was need to evaluate concepts that would modify operations or capacity such as adding / modifying turn lanes and / or signal phasing / timing. For these intersections, Current (2020) and Future Year (2045) volumes were determined through the traffic forecasting process.

The following sections provide the information relative to the development and presentation of the traffic forecast numbers.

**Figure 1. Study Area**




## EXISTING TRAFFIC VOLUMES


**Figure 2. Pendleton and Bracken County Count Stations and 2020 Mainline Volumes**

The most recent AADT volumes on the mainline of the AA Highway (KY 9 and KY 10) in the study area were obtained from the KYTC traffic count reporting system (CTS). The segment, station numbers, mile points, last year of count, and traffic volumes (AADT) are shown in **Table 1**. **Figures 2 through 6** show the forecasted 2020 AADT, truck traffic volumes (AADTT), and design hourly volumes (DHV).




**Figure 3. Mason County Count Stations and 2020 Mainline Volumes**




**Figure 4. Lewis County (KY 9) Count Stations and 2020 Mainline Volumes**

Peak period (AM / PM) turning movement counts were conducted at locations where turn lanes / capacity changes may be considered. **Table 2** displays information about the counts. Counts were conducted for the peak hours only (7:00-9:00 AM and 3:00-6:00 PM) except for Clarkson Sherman Road due to the alternative peak hour of the operation of the landfill (6:45-9:00 AM and 2:30-4:30 PM). All counts were conducted prior to shelter-in-place orders resulting from the COVID-19 pandemic except for the intersections of KY 9/ Clarkson Sherman Road and KY 9 / KY 59. At the KY 9 / Clarkson Sherman Road intersection, the focus of the data collection was to determine the amount of turning truck traffic to the nearby landfill. Based on previous knowledge for the intersection, it was observed by KYTC that the volumes were lower than expected and the peak hour may have not been captured. Therefore, a re-count was determined to likely be needed in the future. The KY 9 / KY 59 intersection was to be counted by KYTC District 9 the week after the shelter-in-place orders and therefore was not able to be counted. However, the intersection was counted in 2015 for a previous study.

## FUTURE TRAFFIC VOLUMES

### *Design Year*

The Design Year for a construction project is typically 20 years beyond the project's opening date per AASHTO's "A Policy on Design Standards – Interstate System". Given the uncertainty of funding and the construction schedule, a design year of 2045 was agreed upon by the Project Team at the initial scoping meeting.

### *Growth Rate / Model Output*

Initial forecasting efforts relied upon historic traffic count data from CTS. The resulting historical growth rate is shown by count station in **Table 3**. Highlighted values in green show stations with positive growth. KYTC also provided data from the KYTC Traffic Forecasting Tool (TFT) which uses the Kentucky Statewide Traffic Model (KYSTM) base and future output values to obtain growth rates. From the count stations provided, KYTC provided a range of growth between 0.2 and 0.5 percent per year. While most count stations show historically negative growth, a select link analysis (procedure to show where traffic comes from and goes to) from the KYSTM shows there are trips that use the AA Highway and travel to neighboring states. Therefore, the AA Highway acts as a regional connector, not just local trips. With this additional information, a growth rate of 0.5% per year was agreed upon with KYTC.

### *2045 Traffic Volumes*




**Figure 7. Pendleton and Bracken County 2045 Mainline Volumes**

The resulting 2045 segment volumes are provided on **Figure 7** through **Figure 11**. The figures include DHV along with AADT and AADTT for mainline segments.

For the intersections counted as part of the improvement analysis, the resulting 2045 forecasted turning movement counts are included in **Appendix C**.




**Figure 8. Mason County 2045 Mainline Volumes**




**Figure 9. Lewis County (KY 9) 2045 Mainline Volumes**

## DESIGN FACTORS

### *K-Factor*

Hourly factors were calculated from the count data collected for the project mainline segments. Specific factors per each segment are included in **Table 4**.

### *D-Factor*

Directional factors were calculated from the count data collected and shown by segment in **Table 4**.

## TRUCK VOLUMES

Truck percentages and volumes were derived from count information available through the KYTC Traffic Count Reporting System and the KYTC Vehicle Classification spreadsheet.

The same growth rate used for overall traffic growth of 0.5 percent per year is recommended to be applied for the truck volumes. Truck volumes by mainline segment are listed in **Table 5**.

Historically, population growth in all six counties is less than that for the state. Population forecasts show decreasing population numbers between 2010 and 2040 for all six counties.
