Dear Mr. Pelfrey,

The proposed Ky. Highway 86 improvement project is long overdue and will be a project that Breckinridge County citizens will welcome. For many years, the traffic flow has exceeded the safe capacity of the highway, and we have encountered numerous problems, including automobile crashes, some of which have been fatal. Improvements are greatly needed, both for the safety of our citizens and also for promoting economic development for our community through improved transportation opportunities.

Upon inspection of your Scoping Study Spot Improvement Map, I would have to say that I can agree with your study. I think you have identified most if not all of our major trouble spots. While all the spots need fixing, I would say that Spot Improvements 2, 3, and 5 are most critical, with spots 6 and 7 being the next most critical. Ideally, the entire road could use a serious upgrade, but realistically that is not likely to happen due to budget constraints. If these spot improvements can be accomplished, however, I feel we will have a much improved and safer highway for our citizens.

In closing, I feel very strongly that this is a much needed project that is long overdue. To my knowledge, I know of no major impediments to the execution of the spot improvements listed for our county, and we will do our best to fully cooperate in any manner to see that this project moves forward with much success.

Mikael, the above attachment shows a reddish approach surface to the Elizabethtown Airport. Any new structure that would exceed the existing surrounding structures (utility poles etc.) would require a permit for the KAZC. The below yellow highlight would apply to your project. Once you have a final plan design, let me know and I will be able to advise you if a permit would be required from the KAZC. Thank you.

602 KAR 50:030. Jurisdiction of the Kentucky Airport Zoning Commission.

RELATES TO: KRS 183.861, 183.867(2), 183.865, 183.867, 183.868, 183.870 STATUTORY AUTHORITY: KRS 183.861

NECESSITY, FUNCTION, AND CONFORMITY: KRS 183.861 authorizes the Airport Zoning Commission to promulgate administrative regulations concerning the use of land within and around designated airports in the Commonwealth. KRS 183.867(2) authorizes the commission to promulgate administrative regulations concerning jurisdiction over zoning of areas over which jurisdiction is assumed. This administrative regulation establishes the areas over which the Kentucky Airport Zoning Commission has zoning jurisdiction and establishes whether a permit shall be required from a property owner.

Section 1. Zoning Jurisdiction. The commission shall have zoning jurisdiction over the airspace above and around the airports designated in KRS 183.861. This jurisdiction shall include the airspace that lies above the surface extending outward and upward at one (1) of the following slopes:

(1) If an airport has at least one (1) runway that is 3,200 feet or more in length, the slope shall be 100 to one (1) for a horizontal distance of 20,000 feet from the closest point of the nearest runway; or

(2) If an airport's longest runway is less than 3,200 feet in actual length, the slope shall be fifty (50) to one (1) for a horizontal distance of 10,000 feet from the nearest point of the nearest runway.

Section 2. Airspace. (1) The commission shall have jurisdiction from the ground upward within the limits of the primary and approach surfaces as depicted on Airport Zoning Maps approved by the Kentucky Airport Zoning Commission, in accordance with KRS 183.867.

(2) The commission shall have jurisdiction over the airspace of the Commonwealth that exceeds 200 feet in height above ground level.

(3) The owner or person with control of a structure that penetrates or may penetrate the airspace over which the commission has jurisdiction shall apply for a permit from the commission, in accordance with 602 KAR 50:090. (KAV-9-1; 1 Ky.R. 807; eff. 5-14-75; Am. 2 Ky.R. 306; eff. 3-10-76; 5 Ky.R. 599; eff. 3-7-79; 10 Ky.R. 445; eff. 1-4-84; 14 Ky.R. 267; eff. 9-10-87; 19 Ky.R. 800; eff. 11-4-92; 27 Ky.R. 2228; 2774; eff. 4-9-2001; 39 Ky.R. 1058; 1881; eff. 4-5-2013.)

The Energy and Environment Cabinet serves as the state clearinghouse for review of environmental documents generated pursuant to the National Environmental Policy Act (NEPA). Within the Cabinet, the Commissioner's Office in the Department for Environmental Protection coordinates the review for Kentucky state agencies.

We received your correspondence dated June 1, 2017. Your letter requested a review of the proposed "KY 86 Planning Study, From US 60 near Garfield to US 62 in Cecilia." The following comments are submitted in reference to this project.

Comments from the Division of Water:

The road construction project has potential to cross or impact several tributaries and streams along the length of US-86 proposed for upgrades. These impacts are expected to be minimal and temporary. For all construction areas, best management practices should be utilized to minimize runoff to nearby waters. However, there are potential impacts to three special use waters in the area: Stony Fork of Sinking Creek, Fiddlers Creek and Rough River.

US-86 traverses through the headwater area of Stony Fork, which is designated as a cold water aquatic habitat. For Stony Fork, water quality standards, which

include specific dissolved oxygen and temperature standards, as found in 401 KAR 10:031, must be maintained during construction of the project.

US-86 also traverses through the headwater area of Fiddlers Creek, which is designated as an outstanding state resource water because it is a Reference Reach and an Exceptional Water. According to 401 KAR 10:031 Section 8, water quality and habitat conditions must be maintained during construction and operation of the project in the area of Fiddlers Creek.

US-86 crosses Rough River approximately 0.8 miles above its designation as an outstanding state resource water because it is a Reference Reach and an Exceptional Water. Again, according to 401 KAR 10:031 Section 8, water quality and habitat conditions must be maintained during construction and operation of the project in the area of Rough River in a manner to prevent downstream impacts. Questions should be directed to Andrea Fredenburg, Water Quality Branch, (502) 782-6950, Andrea.Fredenburg@ky.gov.

Kentucky Revised Statute KRS 151.250, provides for exemption for the Department of Highways; therefore, a "Stream Construction Permit for Construction In or Along a Stream" will not be required. No formal approval is required for Water Withdrawal Permitting or Water Management Planning. Questions should be directed to Julia Harrod, Watershed Management Branch, (502) 782-6967, Julia.Harrod@ky.gov.

The proposed study is endorsed by the Groundwater Section of the Watershed Management Branch. However, the proposed work is located in an area with a high potential for karst development where groundwater is susceptible to direct contamination from surface activities. It is our recommendation that proposed work be made aware of the requirements of 401 KAR 5:037 and the need to develop a Groundwater Protection Plan (GPP) for the protection of groundwater resources within that area. As sinkholes could be present in the area, it is also our recommendation that the proposed work be made aware of the Class V (5) well permitting regulations under the Underground Injection Control (UIC) established by the Environmental Protection Agency (EPA) Region 4. Additionally, nearby domestic wells located along KY 86 should also be considered with respect to the proposed project as referenced in the Environmental Overview. Comments from the Division of Waste Management:

All solid waste generated by this project must be disposed at a permitted facility. If underground storage tanks are encountered, they must be properly addressed.

If asbestos, lead paint, and/or other contaminants are encountered during this project, they must be properly addressed.

Comments from the Division of Air Quality:

Kentucky Division for Air Quality Regulation **401 KAR 63:010** Fugitive Emissions states that no person shall cause, suffer, or allow any material to be handled, processed, transported, or stored without taking reasonable precaution to prevent particulate matter from becoming airborne. Additional requirements include the covering of open bodied trucks, operating outside the work area transporting materials likely to become airborne, and that no one shall allow earth or other material being transported by truck or earth moving equipment to be deposited onto a paved street or roadway. Please note the [Fugitive Emissions Fact Sheet](#).

Kentucky Division for Air Quality Regulation **401 KAR 63:005** states that open burning is prohibited. Open Burning is defined as the burning of any matter in such a manner that the products of combustion resulting from the burning are emitted directly into the outdoor atmosphere without passing through a stack or chimney. However, open burning may be utilized for the expressed purposes listed on the [Open Burning Brochure](#).

The Division would like to offer the following suggestions on how this project can help us stay in compliance with the NAAQS. More importantly, these strategies are beneficial to the health of citizens of Kentucky.

- § Utilize alternatively fueled equipment.
- § Utilize other emission controls that are applicable to your equipment.
- § Reduce idling time on equipment.

Kentucky Department of Fish and Wildlife Resources

The Kentucky Fish and Wildlife Information System (KFWIS) indicates the following federally threatened/endangered species are known to occur within a 10-mile radius of the proposed project site: Clubshell (*Pleurobema clava*), Rabbitsfoot (*Quadrula cylindrica cylindrica*), Northern Myotis (*Myotis septentrionalis*), Gray Myotis (*Myotis grisescens*), and Indiana Bat (*Myotis sodalis*).

Based on this information, KDFWR provides the following recommendations:

- For more information on how to proceed with the federally listed threatened/endangered species located near the project, please contact the US Fish and Wildlife Service Kentucky Field Office at (502) 695-0468.

Please be aware that our database system is a dynamic one that only represents our current knowledge of various species distributions.

- To minimize indirect impacts to aquatic resources strict erosion control measures should be developed and implemented prior to construction to minimize siltation into streams and sinkholes located within the project area. Such erosion control measures may include, but are not limited to silt fences, staked straw bales, brush barriers, sediment basins and diversion ditches. Erosion control measures will need to be installed prior to construction and should be inspected and repaired regularly as needed.
- Avoid impacts to caves and other karst features that are located within the project area. Caves are an important ecological community and provide habitat for a variety of species, including federally listed bats.

KDFWR recommends that you contact the appropriate US Army Corps of Engineers office and the Kentucky Division of Water prior to any work within the waterways or wetland habitats of Kentucky.

Additionally, KDFWR recommends the following for the portions of the project that impact streams:

- Channel changes located within the project area should incorporate natural stream channel design.
- If culverts are used, the culvert should be designed to allow the passage of aquatic organisms.
- Culverts should be designed so that degradation upstream and downstream of the culvert does not occur.
- Development/excavation during low flow period to minimize disturbances.
- Proper placement of erosion control structures below highly disturbed areas to minimize entry of silt into area streams.

- Return all disturbed instream habitat to a stable condition upon completion of construction in the area.
- Preservation of any tree canopy overhanging any streams within the project area.

The Kentucky Division for Air Quality has reviewed the subject submittal. Based on this review, the Division offers the following comments.

401 KAR 63:010, Fugitive Emissions, states that no person shall cause, suffer, or allow any material to be handled, processed, transported, or stored without taking reasonable precaution to prevent particulate matter from becoming airborne. Additional requirements include the covering of open bodied trucks, operating outside the work area transporting materials likely to become airborne, and that no one shall allow earth or other material being transported by truck or earth-moving equipment to be deposited onto a paved street or roadway. 401 KAR 63:005 states that open burning shall be prohibited except as specifically provided. I am writing in response to the KY 86 Planning Study. I have also forwarded and attached a copy of the collision we as KSP post 04, have worked from January 1, 2016 until present. We recognize there is a strong need for improvements for KY 86 Between US 60 and US 62. It is a vital roadway that connects Breckinridge and Hardin Counties and is a main thoroughfare for many residents. It is known as a rural, narrow road with several sharp curves. As you can see from the attachments, we have worked several collisions scattered throughout the entire section of roadway. Many of these collisions are single vehicle which mainly accounts for the many sharp curves that operators are failing to negotiate. There are some head-on collisions also in this number which could be contributed to the narrowness of the road. While human contributing factors can mostly be contributed to for collisions, there is an element of environmental contributing factors due to the roadway itself. The majority of the roadway has low shoulders and is narrow. By widening the road and adding adequate shoulders to both sides, it would significantly improve the roadway, thus driving conditions. A few specific places along this roadway can also be noted. The section of roadway known as "Arch Hill" which is near Grandview Church, near the Breckinridge County line seems to produce many problems for motorists. The section of road east of Franklin Crossroads has some "dangerous" S-curves. The High Valley School area also has sharp curves and seems to be banked awkwardly going into a hill. These are just a few specific areas we see problems with. KY 86 is a roadway our Troopers patrol regularly, and it always produces many traffic violations with our Troopers issuing many speeding and seatbelt violation citations there. Obviously, many drivers operate their vehicles too aggressively for the present roadway conditions of KY 86, but by improving the roadway, we believe it could significantly decrease the amount of collisions and traffic problems we have in that area.

I assigned the local commander your request regarding the Kentucky 86 road study, since his personnel would have far greater knowledge of the area. Below are comments as to the information you provided as well as input from Commercial Vehicle Enforcement personnel that evaluated the study areas:

"The locations listed in the plans, I too have found to be problem areas for both CMV's and passenger vehicles. These problem areas contain blind curves that have a pitch causing a vehicle to roll in the opposing direction, a roadway which is narrow and unable to accommodate vehicles with any width about them. With the commercial traffic that is currently traveling this roadway, repairs are in need."

"Commercial vehicles, due to the road classification are restricted from using this roadway. If the plans are to widen the roadway and strengthen the base of the road, I feel that commercial traffic may be able to resume utilizing the roadway. However, with the latest addition of the Patriot Parkway (KY361) now intersecting with KY313 (Joe Prather) this has made traveling to US60 a better choice. If the plans to make KY86 suitable for commercial traffic, the roadway will need to be able to accommodate vehicles greater than 65 feet in length, 102 inches in width and 13'6" in height, as well as being able to handle maximum allowable weight of 80,000 pounds. I feel that the roadway can be improved to accommodate these vehicles and assist in the shorter distances to the specified roadways."

We would like to provide the following comments that may be helpful in the initial scoping process.

There are no PACE, (Purchase of Agricultural Conservation Easements) or established agricultural districts within or near the study area.

One concern we would like to comment on is the control of erosion and sedimentation if any proposed improvements proceed to construction phase. We recommend Best Management Practices, BMP's, be utilized to prevent nonpoint source water pollution. This would protect the water quality and aquatic habitat of any perennial or intermittent streams construction activities could impact.

KY 86 Scoping Study Breckinridge and Hardin County Spot Improvement Locations









Thank you for your June 1, 2017, letter to Ms. Natalie Perry, formerly the Acting Regional Director, of the U.S. Department of Health and Human Services (HHS), Region IV, requesting comments by June 30, 2017, on the Kentucky Transportation Cabinet's study to evaluate potential improvements on KY 86. Ms. Perry forwarded your letter to me for response.

We are pleased that you reached out to us for input and comments on the KY 86 study. The physical environment plays an important role in health outcomes for Americans and safe, efficient transportation can be a key contributor to a healthy community. In an effort to identify potential public health impacts for the proposed project, we reached out to local health directors in the impacted counties to gather input on the potential for this project to impact access to health care, health behaviors, and the socioeconomic and physical environments. As a result, I am pleased to share our comments.

Comments on the Draft Purpose and Need for the Project

Based on the extremely curvy and narrow nature of the road and the difficulty to pass, it appears that improvements to the KY 86 would increase the timeliness of access to health care facilities, such as Hardin Memorial Hospital. Widening of the road, decreasing hills and curves should create a safer and easier travel way for school buses, ambulances, as well as the general public making the commute easier to Elizabethtown and Hardinsburg.

The project may also increase access to healthy foods. Many of the groceries listed are no longer in business (Country Crossroads Grocery closed in 2013, Yates Grocery closed in 2000). There is very limited access to food; only one small convenient store is located on 86 (Fields Country Store located at the 920 intersection of highway KY 86). A Dollar General and gas station are located on Hwy 62 in close proximity to 86. If this project increases the amount of traffic going through this area, it may increase the feasibility of more businesses including groceries.

Locations of Known Areas to Consider to Minimize or Mitigate Impact


There is a new school under construction on the end of 86 next to the intersection 62. The intent for this building is to house both the former Howe Valley Elementary School (located on the current map) as well as West Hardin Middle School (not on your map, located in Stephensburg, KY). This means an increase in traffic on this end of KY 86 near the intersection on 62.

There is no city sewer in the community of Cecilia which may necessitate the review for the current onsite septic systems, since the lot sizes for most of these properties are small and the new construction may take portions of residential property should the project include widening KY 86 or rerouting it. Expansion of municipal sewer would definitely help this community. The school is scheduled to have sewer but no current plans to include the other community structures have been communicated at this time.

Sidewalks are located in the Cecilia area only. Other areas along this route do not have designated walking or biking areas. The road is narrow and contains various hills and curves, so walking or biking could be unsafe. Because of the rural nature of most of this highway, it appears that areas outside of Cecilia would not be feasible options for sidewalks.

Thank you for the opportunity to review, and I hope these comments are helpful.

Based upon our understanding of the proposed action, we have no comments at this time. The EPA is unaware, at this time, of any known conservation or development plans it has ongoing within the project area. Thank you for the opportunity to review and comment

Background:

The U.S. Environmental Protection Agency is responding to a June 1, 2017, request for input and comments on the SR 86 corridor planning study, specifically with regard to 1) the proposed action's purpose and need, 2) significant issues to facilitate appropriate project scoping, 3) any ongoing agency efforts within the project area, 4) the locations of any known issues to be considered when developing alternatives, and 5) any mitigation strategies to be considered during project development. Our understanding of the material provided: maps of SR 86 corridor, high crash spots, horizontal and vertical curve deficiencies, preliminary spot improvement locations, and environmental overview) is that KTC proposes to undertake spot improvements but no major road alignments or road construction.

Affected Environment:

SR 86 appears to traverse a rural landscape of mixed pasture/hay and grassland uses interspersed with tracts of deciduous and evergreen trees. Agriculture (corn, soybeans, and tobacco) has been reported as an important part of the Breckinridge County economy. The SR 86 study area includes two counties: 10.18 miles in Breckinridge and 16.15 miles in Hardin. Within the study area, SR 86 appears to cross the following streams: Rough River, Vertrees Creek, Blacks Branch Creek, West Rhudes Creek, and an unnamed stream (East Rhudes Creek?). Two of the proposed spot improvements affect two of these streams: Spot Improvement (SI) #11 includes the Rough River bridge and SI #17 includes the culvert at Blacks Branch Creek.

Purpose & Need:

The proposed SR 86 study's purpose is to determine the need, short-term improvements that can be implemented quickly and effectively, potential impacts, and long term solutions to address future transportation needs along the to enhance regional mobility and provide a safer, more efficient east/west corridor across Breckinridge and Hardin Counties that connects the communities of Hardinsburg, Cecilia, Elizabeth town, and the roadways of West Kentucky Parkway and I-65. Hardinsburg is the Breckinridge County seat, 2010-census population of 2,343. Cecilia is an unincorporated community 5 miles west of Elizabethtown and within the Elizabethtown-Ft. Knox Metropolitan Statistical Area. Elizabethtown is the Hardin County seat, 2010-census population of 29,335

The provided materials included a list of 19 SI segments and a list of 19 SR 86 high-crash spot

segments. High crash spots have been defined as 0.3-mile roadway segments with a critical rate factor (CRF) greater than 1. This information seems to indicate that 6 of the proposed SI (#3, 4, 8, 11, 17, & 19) do not overlap any of the 19 listed high-crash spot segments. Two of the SI segments (SI #5 and 7) appear to overlap two high-crash spot segments having a $CRF > 2$. Eight of the proposed SIs (#1, 2, 5, 6, 12, 14, 16, and 18) overlap 9 of the high-crash spot segments in the vicinity of SR 86's intersection with 8 roads: 6 county and 2 state roads. None of the listed SI segments affecting streams appear to overlap any of the identified high-crash spot segments.

Dear Project Proponent:

We have received your request for a species list for your project. The Kentucky Field Office (KFO) is directing project proponents to obtain species lists from the U.S. Fish and Wildlife Service (USFWS) Information for Planning and Conservation (IPaC) system located at: <https://ecos.fws.gov/ipac/>. IPaC will immediately provide you with a current species list appropriate for your proposed project and an official letter on USFWS letterhead. This list will include species currently listed as threatened or endangered, species proposed for listing, critical habitat for listed species, and bird species of conservation concern.

When you open the IPaC site, you will be asked to input a location for your proposed project. The location can be input in different ways. Often, the easiest way is to zoom into the vicinity of the project area on the map and use the sketch tool to approximate the boundaries of the proposed project site, plus an appropriate buffer. This location that you input should represent the entire "action area" of your proposed project by considering all the potential "effects of the action," including potential direct, indirect, and cumulative effects to federally-listed species or their critical habitat as defined in 50 CFR 402.02. This includes effects of any "interrelated actions" that are part of a larger action and depend on the larger action for their justification and "interdependent actions" that have no independent utility apart from the action under consideration (e.g.; utilities, access roads, etc.) and future actions that are reasonably certain to occur as a result of the proposed project (e.g.; development in response to a new road).


IPaC will generate a species list specific to the action area of the proposed project, as you defined it. You can then request an official species list under the "Regulatory Documents" tab. This species list fulfills the requirements of the USFWS under section 7(c) of the Endangered Species Act (ESA) of 1973, as amended (16 U.S.C. 1531 et seq.) to provide information as to whether any proposed or listed species may be present in the area of a proposed action. The letter generated by IPaC will explain how to request an updated list or a revised list based on project modifications.

The official species list is not a concurrence letter; additional coordination with the KFO may be necessary to ensure ESA compliance. Please read the letter that accompanies the species list for further direction as to how to request technical assistance or section 7 consultation from the KFO. Please include the consultation tracking number on the IPaC-generated letter (e.g., 04EK1000-####-SLI-####) at the top of your future correspondences with the KFO. The KFO

will be able to retrieve the information that you input into IPaC; there is no need to include a printed copy of your IPaC-generated letter or species list with your correspondence.
