



# **APPENDIX C: EXISTING AND COMMITTED (E + C) PROJECTS**

During the SWIPP development, KYTC identified a list of the existing and committed (E+C) projects with major roadway capacity improvements throughout the state. These projects included the Strategic Highway Investment Formula for Tomorrow (SHIFT) priority projects, E+C projects considered in the Statewide Corridor Plan (SWCP), and other major projects identified by KYTC. These projects were properly coded into 2030 and 2045 networks in v8\_KYSTMv19, based on the anticipated project completion timeline determined using project information from KYTC. The 2030 and 2045 E+C networks serve as the “Base” scenarios for intermediate (2030) and long-term (2045) analysis respectively in the SWIPP. **Table C.1** summarizes these E+C projects.
