I am pleased to write you in support of the National Interstate 69 Complete Section of Independent Utility (SIU) 5 Corridor project that seeks funding under the TIGER II Discretionary Grant Program. The Commonwealth of Kentucky is honored to take the lead in the effort to secure grant funding for this project.

This project will convert the existing fully controlled facility to Interstate 69 and complete the entire 80 mile SIU 5 segment plus minor design exceptions and variances. This segment is an ideal candidate for the rural funding portion of the TIGER II grant program. I wish to state my support for funding a portion of Interstate 69 along our existing parkways. The Ford and Breathitt Parkways meet AASHTO interstate guidelines for most of the design elements. Many of the deficiencies could be considered acceptable under the principle of design flexibility allowed by AASHTO.

Kentucky understands the importance of completing National I-69. With increased trade in both Canada and Mexico, I-69 is a key corridor for national freight movement and enhancing U.S. global competiveness. Improvements planned for the Panama Canal will increase north-south travel demands along the I-69 Corridor in a few short years.

The TIGER II Grant represents a great opportunity to move I-69 forward in Kentucky. Our General Assembly recently passed a Highway Plan that programmed \$51 million for I-69 Corridor projects in Kentucky. Of that, \$24 million is programmed for safety and operational improvements along the Ford and Breathitt Parkways that will allow future conversion to I-69.

Federal funding to complete I-69 in Kentucky is desperately needed. If funding should be awarded to complete Section of Independent Utility 5 on National I-69, it would be a national asset and of enormous benefit to all communities from Henderson to Eddyville in providing new jobs, preserving jobs, and providing growth opportunities for the future.



I urge your support of the Commonwealth of Kentucky's application for TIGER II grant money to further the opening of a large section of Interstate 69 in western Kentucky.

We are fortunate that Kentucky built an extensive system of four-lane, limited access parkways in the 1960s and 1970s. Much of the Purchase, Western Kentucky and Pennyrile parkways will be upgraded to become I-69. SIU5 covers approximately 75 miles and could take significant steps to being officially "shielded" with a positive result from the TIGER II grant.




