The routes as designated hereinafter were established by OFFICIAL ORDER # 86605 on March 18, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 31E, from the Tennessee State Line, via the Scottsville Bypass, to the Barren County Line, a distance of 19.189 miles. (MP 0.000 to MP 19.189)

US 231, from the junction with US 31E in Scottsville, via Halfway to the Warren County Line, a distance of 8.569 miles. (MP 0.000 to MP 8.569)

KY 100, from the Simpson County Line, via Alonzo and Chapel Hill, via Old Franklin Road, South Court Street, East Main Street, 5th Street, and Holland Road in Scottsville to the junction with KY 1421, a distance of 17.244 miles. (MP 0.000 to MP 17.244)

KY 101, from the junction with KY 100 in Scottsville, via Meador, to the Warren County Line, a distance of 13.347 miles. (MP 0.000 to MP 13.347)

KY 234, from the junction with KY 101, via Yesse and Settle, to the Warren County Line, a distance of 6.381 miles. (MP 0.000 to MP 6.381)

KY 482, from the junction with KY 100, via Fleet, to the junction with US 31E, a distance of 8.368 miles. (MP 0.000 to MP 8.368)

KY 517, from the junction with KY 252, northwest of the junction with US 31E, to a point at the end of state maintenance that is 0.140 mile south of the Tom Odom Road, a distance of 2.800 miles. (MP 0.000 to MP 2.800)

KY 585, from the Simpson County Line, via Mount Aerial and Red Hill, to the junction with KY 100, a distance of 8.865 miles. (MP 0.000 to MP 8.865)

KY 671, from the junction with KY 100 at Oak Forrest to the junction with KY 98, a distance of 4.570 miles. (MP 0.000 to MP 4.570)

KY 921, from the junction with KY 98 to the Barren County Line, a distance of 0.605 mile. (MP 0.000 to MP 0.605)

KY 1147, from the Tennessee State Line to the junction with US 31E at Petroleum, a distance of 4.996 miles. (MP 0.000 to MP 4.996)

KY 1332, from the junction with KY 585, via Pope and Butlersville, to the junction with KY 3241 at West Fork. Also, from another junction with KY 3241 near Halfway, via Halifax to the junction with KY 101 near Scottsville, a distance of 16.122 miles. (MP 0.000 to MP 5.814)(MP 5.814 to MP 16.122)
