STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Barren County is current as of March 27, 2024. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86606 on March 18, 1982, and OFFICIAL ORDER # 86969 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-65, from the Warren County Line to a point on the Edmonson County Line. Also, from another point on the Edmonson County Line to the Hart County Line, a distance of 8.438 miles. (MP 42.890 to MP 43.307)(MP 45.935 to MP 53.956)

LN 9008 (Louie B. Nunn Cumberland Expressway), from the bridge over I-65 near the Warren County Line, via Glasgow, to the Metcalfe County Line, a distance of 22.357 miles. (MP 0.000 to MP 22.357)

US 31E, from the Allen County Line, via the Glasgow Bypass in Glasgow, to the intersection with KY 90 (Happy Valley Road) in Glasgow, a distance of 14.849 miles. (MP 0.000 to MP 14.849)

US 31EX (Business Route), from the junction with East Washington Street in Glasgow, via South Green and East Main Streets, to the junction with US 68 at North Race Street; including the one way couplet (southbound) from the junction with US 68 (West Main Street), via South Race and West Washington Streets, to the junction with South Green Street, a distance of 0.110 mile. (MP 1.406 to MP 1.516)

US 68X (Business), from the intersection with US 31E in Glasgow to the intersection with US 31EX (Business). Also, from another intersection with US 31EX (Business) to the junction with KY 90, a distance of 0.909 mile. (MP 1.692 to MP 2.528)(MP 2.528 to MP 2.601)

KY 70, from the west limits of the I-65 interchange near Cave City to the intersection with KY 90, a distance of 0.194 mile. (MP 5.085 to MP 5.279)

KY 90, from the junction with KY 70, east of the I-65 interchange at Cave City, to the junction with US 31E (N.L. Rogers Wells Blvd.) in Glasgow. Also, from the junction with US 68 (North Broadway Street) in Glasgow, via East Main Street in Glasgow and via Eighty Eight, to the Metcalfe County Line, a distance of 21.949 miles. (MP 0.000 to MP 9.923)(MP 9.923 to MP 21.949)

### **STATE SECONDARY SYSTEM**

US 31E, from the intersection with KY 90, via the Glasgow Bypass in Glasgow, via Griderville, to the Hart County Line, a distance of 11.008 miles. (MP 14.849 to MP 25.857)

US 31EX (Business Route), from a junction with US 31E (Glasgow Bypass) north of the Louie B. Nunn Cumberland Expressway interchange, via South Green Street, to the intersection with East Washington Street in Glasgow. Also from the junction with US 68 (West Main Street), via North Race Street, to another junction with US 31E (Glasgow Bypass) near Glasgow, a distance of 3.130 miles. (MP 0.000 to MP 1.406)(MP 1.516 to MP 3.240)

US 31W, from the Edmonson County Line, via Second Street in Park City and via Cave City, to the Hart County Line, a distance of 8.905 miles. (MP 0.000 to MP 8.905)

US 68, from the Warren County Line, via Merry Oaks, and Glasgow to the Metcalfe County Line, a distance of 23.159 miles. (MP 0.000 to MP 23.159)

US 68X (Business), from the west junction with US 68 in Glasgow to the intersection with US 31E. Also, from the junction with KY 90 to the intersection with US 68 and KY 1519, a distance of 3.687 miles. (MP 0.000 to MP 1.692)(MP 2.601 to MP 4.596)

KY 63, from the Monroe County Line, via Temple Hill and via Mill Street, South Franklin Street and East College Street in Glasgow, to the junction with US 31EX (Business Route)(South Green Street) in Glasgow, a distance of 14.546 miles. (MP 0.000 to MP 14.546)

KY 70, from the Edmonson County Line, via Highland Springs to the West Limits of the I-65 interchange in Cave City. Also, from the intersection with KY 90 at a point east of the I-65 interchange, via Broadway in Cave City and via Griderville, Hiseville, and Halfway, to the Metcalfe County Line, a distance of 19.049 miles. (MP 0.000 to MP 5.085)(MP 5.279 to MP 19.243)

KY 3600 (Glasgow Outer Loop), from the junction with KY 1297 (Old Bowling Green Road), south of LN-9008 (Louie B. Nunn Cumberland Expressway) interchange, via Glasgow Outer Loop, to the intersection with US 68X (Business) in Glasgow, a distance of 2.501 miles. (MP 0.000 to MP 2.501)
