## BATH COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Bath County is current as of <u>December 19, 2022.</u> Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85715 on November 20, 1980, and OFFICIAL ORDER # 86970 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

#### STATE PRIMARY SYSTEM

I-64, from the Montgomery County Line to the Rowan County Line, a distance of 13.308 miles. (MP 115.647 to MP 128.955)

KY 11, from the Montgomery County Line, via Sharpsburg to the Fleming County Line, a distance of 12.288 miles. (MP 0.000 to MP 12.288)

#### **STATE SECONDARY SYSTEM**

US 60, from the Montgomery County Line, via Owingsville, Polksville, Salt Lick and Midland to the Rowan County Line. Also from another point on the Rowan County Line to another point on the Rowan County Line, a distance of 20.111 miles. (MP 0.000 to MP 19.811)(MP 19.811 to MP 20.111)

KY 36, from the Nicholas County Line to the junction with KY 11, north of Sharpsburg. Also, from another junction with KY 11 near Sharpsburg, via Reynoldsville to the junction with US 60 in Owingsville. Also, from another junction with US 60 in Owingsville, via Olympia and Olympia Springs to the Menifee County Line, a distance of 23.860 miles. (MP 0.000 to MP 0.890)(MP 0.890 to MP 11.847 to MP 23.860)

KY 111, from the junction with US 60 near Owingsville, via Slate Valley to the Fleming County Line, a distance of 8.054 miles. (MP 0.000 to MP 8.054)

- KY 211, from the junction with KY 36, north of the Menifee County Line to the junction with US 60 in Salt Lick, a distance of 6.949 miles. (MP 0.000 to MP 6.949)

- KY 965, from the Montgomery County Line to the junction with KY 36, south of I-64. Also, from another junction with KY 36, northwest of Olympia to the junction with US 60, southeast of I-64, a distance of 10.565 miles. (MP 0.000 to MP 7.997)(MP 7.997 to MP 10.565)
- KY 1106, from the junction with KY 1325, north of Reynoldsville to the junction with KY 11 near Bethel, a distance of 5.445 miles. (MP 0.000 to MP 5.445)
- KY 1198, from the Nicholas County Line to the junction with KY 11, southwest of Sharpsburg. Also, from another junction with KY 11 in Sharpsburg, to the junction with US 60, west of Owingsville, a distance of 9.825 miles. (MP 0.000 to MP 1.789)(MP 1.789 to MP 9.825)
- KY 1269, from the junction with US 60, northwest of I-64, via Peasticks to the junction with KY 211, a distance of 6.269 miles. (MP 0.000 to MP 6.269)
- KY 1325, from the junction with KY 36 at Reynoldsville to the junction with KY 11 near the Fleming County Line, a distance of 7.599 miles. (MP 0.000 to MP 7.599)
- KY 1331, from the Montgomery County Line to the junction with KY 965, a distance of 3.344 miles. (MP 0.000 to MP 3.344)
- KY 1602, from the junction with KY 1325, via Pebble and Oakla, to the junction with KY 111 near Wyoming, a distance of 7.057 miles. (MP 0.000 to MP 7.057)
- KY 1944, from the junction with KY 36, northwest of Owingsville to the junction with KY 111 near Wyoming, a distance of 6.413 miles. (MP 0.000 to MP

6.413)

KY 3288, from the junction with KY 36, east of Sharpsburg to the junction with KY 1106, a distance of 3.101 miles. (MP 0.000 to MP 3.101)

KY 3289, from the Montgomery County Line to the junction with KY 11 south of Sharpsburg, a distance of 4.164 miles. (MP 0.000 to MP 4.164)

KY 3290, from the junction with KY 36 at Olympia Springs to the junction with KY 211, a distance of 4.117 miles. (MP 0.000 to MP 4.117)

#### **SUPPLEMENTAL ROADS**

KY 6217, FRONTAGE ROAD NO. 2, from the beginning of state maintenance, southwest of US 60, extending northeast and parallel with the north side of I-64, via Wells Road to the end of state maintenance, southwest of US 60, a distance of 0.435 mile. (MP 0.000 to MP 0.435)

KY 6218, FRONTAGE ROAD NO. 3 , from the beginning of state maintenance, northeast of US 60, extending northeast and parallel with the south side of I-64, via Old Peasticks Road to the end of state maintenance, northeast of US 60, a distance of 0.469 mile. (MP 0.000 to MP 0.469)

KY 6219, VANCE ROAD, from the beginning of state maintenance west of KY 211, extending east and parallel with the south side of I-64 to the junction with KY 211, a distance of 0.477 mile. (MP 0.000 to MP 0.477)

KY 6220, FRONTAGE ROAD, from the junction with KY 211 at a point south of the I-64 Overpass, extending northeast to the end of state maintenance, a distance of 0.143 mile. (MP 0.000 to MP 0.143)
